A City of Sunrise Juried Art Exhibit Showcasing Broward Teens

Exhibit and Reception Dates

- Select winning entries will be displayed as part of **Sankofa: Looking Forward, Reaching Back** – a City of Sunrise exhibit in celebration of the legacy of Martin Luther King Jr. **Sankofa** will be on display from January 13 to February 25, 2017, and winning teen artists will be recognized alongside professional artists at an opening reception on Sunday, January 15, at 6:00 p.m. in the Sunrise Civic Center Art Gallery.
- All accepted student entries will be displayed in the Art Gallery from February 18 through February 25.

Submission Requirements

- Art should be relevant to the theme **Sankofa: Looking Forward, Reaching Back**. The exhibit is intended to illustrate how we must learn from the past to ensure a strong future.
- Artists must live in Broward County and be enrolled in high school for the 2016-2017 academic year.
- Art will be accepted in these categories: graphic design, digital media, acrylic, oil, watercolor, pencil, photography, sculpture, and mixed media.
- Each entry must be an original work completed within the last two years.
- A maximum of four works per artist will be accepted. A separate entry form is required for each piece.
- Two-dimensional artwork must be dry, framed, and wired for hanging with screw eyes and wire (no saw-tooth hangers). Three-dimensional artwork must have front/back orientation indicated.

Intake Dates

Artists will have two opportunities to bring their work and completed entry forms to the Sunrise Civic Center (10610 West Oakland Park Boulevard, Sunrise 33351):

- Wednesday, January 11, from 1:00 p.m. to 4:00 p.m. in the Leisure Services Department (second floor)
- Thursday, January 12, from 4:00 p.m. to 7:00 p.m. in the Sunrise Civic Center Art Gallery (first floor)

Artist Notification

Winning artists will be notified no later than Friday, January 13. All artwork must be picked up in the Sunrise Civic Center Art Gallery on Monday, February 27, between 3:00 p.m. and 5:00 p.m.

Awards

First, Second and Third Place will be awarded in each category, unless there are an insufficient number of entries. Best in Show will also be selected. Jurors and prizes TBD.
