AN ORDINANCE OF THE CITY OF SUNRISE, FLORIDA, AMENDING FISCAL YEAR 2011/2012 BUDGET ORDINANCE NO. 541, TO AMEND THE POLICE CONFISCATION/FORFEITURE FUND (FUND 610), PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF SUNRISE, FLORIDA:

Section 1. Fiscal Year 2011/2012 Budget Ordinance No. 541, is hereby amended to revise the estimated revenues and requested appropriations for the Police Confiscation/Forfeiture Fund (Fund 160), as more particularly set forth in the revised budget sheets which are attached to, and made a part of this Ordinance as Exhibits "A."

Section 2. Conflict. All ordinances or parts of ordinances, all City Code sections or parts of City Code sections, and all resolutions or parts of resolutions in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 3. Severability. Should any provision of this Ordinance be declared by a court of competent jurisdiction to be invalid, the same shall not affect the validity of the
