ORDINANCE NO.

AN ORDINANCE OF THE CITY OF SUNRISE, FLORIDA, AMENDING FISCAL YEAR 2011/2012 BUDGET ORDINANCE NO. 541, TO AMEND THE GENERAL FUND (FUND 001), DECREASING THE FUND BALANCE ESTABLISHED BY RESOLUTION NO. 11-122 IN THE GENERAL FUND FOR ECONOMIC DEVELOPMENT; PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF SUNRISE, FLORIDA:

Section 1. Fiscal Year 2011/2012 Budget Ordinance No. 541, is hereby amended to revise the estimated revenues and requested appropriations for the General Fund (Fund 001), as more particularly set forth in the revised budget sheets which are attached to, and made a part of this Ordinance as Exhibits "A."

Section 2. Conflict. All ordinances or parts of ordinances, all City Code sections or parts of City Code sections, and all resolutions or parts of resolutions in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 3. The General Fund for Economic Development established by Resolution No. 11-122 is hereby reduced by 245,000 to 9,755,000.
