Background:

General Fund 001

A. Funding is being transferred from the Non-Departmental Contingency account to fund two Police Officer positions in the Police Department budget. In the current budget, there are five unfunded Police Officer positions. The City applied for the Cops Hiring Program Grant, which would have enabled the City to fund six police officers, 75% from the grant and 25% from the City's required match (funding has been set aside in the Contingency Account).

Recently, the Police Department was notified that the City was not awarded the grant. As such, the department is requesting to fund two Police Officer positions for the remainder of this fiscal year with the monies set aside in the Contingency Account.

B. Funding is being transferred from the Contingency Account to provide for additional grounds maintenance shrub shearing services. The reorganization of the Public Works Department eliminated two positions that were performing these tasks and the need for outsourcing this function was identified very late in the budget development process. This action provides the required funding for this contractual service, 20% is funded by the General Fund (the remaining 80% will be funded in Stormwater Fund).

UASI Grant Fund 140

C. The budget is being increased in the Urban Area Security Fund (140) for the recently awarded 2012 UASI Grant from the U.S. Department of Homeland Security. Both the revenues and related expenditures are budgeted.

Utilities Renewal & Replacement Fund 402

D. The budget was built on initial projections for capital project costs for Water and Wastewater projects. This action does not change the total budget in Fund 402, but reallocates project funding from Wastewater projects to Water projects based on more current projections.

Stormwater Fund 444

E. Funding is being appropriated to provide for additional grounds maintenance shrub shearing services. The reorganization of the Public Works Department eliminated two positions that were performing these tasks and the need for outsourcing this function was identified very late in the budget development process. This action provides the required funding for this contractual service, 80% of which are funded by the Stormwater Fund.
