- 1. A Fire Inspector with Sunrise Fire Rescue (Personnel meeting eligibility criteria under this method are eligible only for assignment as a Fire Captain in the Fire Life Safety Division)
- 2. Must possess and maintain State of Florida Paramedic certification as described in Florida Department of State; Florida Administrative Code and Florida Administrative Register
- 3. Possess a valid and appropriate State of Florida Class E (or greater) driver's license and successful completion of a certified EVOC program (Chapter 322, Florida Statute, and Rules 64E-2 of the Florida Administrative Code.
- 4. Must possess Municipal Fire Officer II Certificate issued by the Florida Bureau of Fire Standards.
- 5. Certification by the Board of Rules and Appeals and State of Florida as a Fire Safety Inspector (Fire Inspector eligible candidates only)

TESTING ELIGIBILITY CRITERIA *

PROMOTIONAL ELIGIBILITY CRITERIA**

- 1. Six (6) years of continuous service with Sunrise Fire Rescue Department. Service time will be reduced by one (1) year with an applicable Associates or Bachelor's Degree from an accredited college or university having met the approval of the City's tuition reimbursement program or according to Florida Statute 633.
- 2. Fire Inspector with Sunrise Fire Rescue for 2 years
- ** Must be met by promotion date, unless otherwise specified.

PROMOTIONAL CRITERIA

- 1. All applicants meeting all criteria for promotion at the time the test results are signed by the Fire Chief shall be in a ranked order of highest score down.
- 2. All applicants not meeting all criteria at the time the test results are signed by the Fire Chief shall be ranked and remain in order of when they will become eligible for promotion.
- 3. Ties in scoring shall be broken by the time stamp on the promotional application.

APPLICATION PROCESS

- ✓ Certificate of Completion for Emergency Vehicle Operation Course (EVOC)

SCHEDULE OF TESTING

The written examination will begin on Tuesday, Tuesday, April, 17, 2018 @ 0930 hours and is expected to take all morning. The uniform of the day will be Class B as described in OPM 300.04. No other pins or ornaments may be worn.

The practical assessment will begin on Wednesday, April 18, 2018 @ 0900 hours, continuing (if necessary) on Thursday, April 19, 2018 @ 0900 hours.

<u>The uniform of the day will be Class C</u> as described in OPM 300.04. A uniform tee shirt long or short without rank will be issued the day of the written exam to be worn for the practical components.

Personnel reporting late for any section of the exam will not be allowed to participate in the exam process.

TESTING PROCEDURE

- A. The written test and assessment center will be conducted by an external testing consultant.
 - → IMPORTANT NOTE: A special meeting will be held on Wednesday, January 31, 2018 @ 0900hrs at Sunrise Public Safety Building, 10440 West Oakland Park Blvd. to discuss the written examination and assessment center format. The consultant will be present to review the testing process and to answer general questions from participants. This meeting is voluntary failure to attend will have no adverse impact on participation in the testing process. However, attendance is recommended, in order that any questions participants may have can be answered.
- B. A passing score of 70% is required on the written as well as the practical component of the test.
- C. The scoring for the test will be weighted as follows: 60% for the practical component and 40% for the written component.
- D. A suggested reading list is attached to this announcement. The reading list, while not all-inclusive, may assist candidates in preparation for the examination process.

ELIGIBILITY LIST

The eligibility list becomes effective on the day it is signed by the Fire Chief. It is on this date the previous eligibility list is no longer valid.

SELECTION PROCESS

Pursuant to the collective bargaining agreement, the City may select any one of the top five (5) eligible candidates for appointment.
