ORDINANCE NO. <u>625-18-B</u>

AN ORDINANCE OF THE CITY OF SUNRISE, FLORIDA, AMENDING FISCAL YEAR 2017/2018 BUDGET ORDINANCE NO. 625; AMENDING THE GENERAL FUND (001), AND THE POLICE CONFISCATION - STATE FUND (196); REDUCING THE ECONOMIC DEVELOPMENT FUND BALANCE ESTABLISHED BY RESOLUTION NO. 11-122; PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF SUNRISE, FLORIDA:

<u>Section 1</u>. Fiscal year 2017/2018 Budget Ordinance No. 625 is hereby amended to revise the General Fund (001) and the Police Confiscation - State Fund (196), as more particularly set forth in the revised budget sheets which are attached to, and made a part of this Ordinance as Exhibit "A."

<u>Section 2. Economic Development Fund Balance</u>. Pursuant to Resolution No. 11-22, the Economic Development Fund Balance is reducing by \$613,513 which reduces the balance from \$8,107,607 to \$7,494,094.

<u>Section 3. Conflict.</u> All ordinances or parts of ordinances, all City Code sections or parts of City Code sections, and all resolutions or parts of resolutions in conflict with this Ordinance are hereby repealed to the extent of such conflict.

<u>Section 4. Severability</u>. Should any provision of this Ordinance be declared by a court of competent jurisdiction to be invalid, the same shall not affect the validity of the ordinance as a whole, or any part thereof, other than the part declared to be invalid.
