Karen once again brought up the idea of having a communitywide garage sale or flea market for residents to get rid of old stuff.

Sophia said the City has already considered having an event like this and decided for a number of reasons not to hold it. Lou agreed and said logistics, liability were the main reasons. He said there is bulk pick up and many charitable organizations that would be delighted to take donations for gently used items.

G. MARKETING UPDATE- LOU SANDORA

Lou told the board that he had several big office relocation deals he was hoping to wrap up before he retires in May. He also said there are a few healthcare projects that he would like to get done as well.

Lou told the board that the most recent office space study indicated that Sunrise has the strongest office market of any city. He said the study was done by the national real-estate firm of CBRE had Sunrise ranked as the lowest office vacancy rate in So Florida at 3.6 %.

H. BOARD MEMBERS DISCUSSION

Steve and Roberta said that Relay for Life held an event at Plantation Central Park but there was no official representation from Sunrise. Lou said that the City has done several fundraising events for Relay for life and that the employees hold held several bake sales throughout the year for the cause. He said the Clerk's office, HR, and Fiancé departments have all participated in baking and preparing food.
