SUMMER CAMP REGISTRATION PROCEDURES



CITY OF SUNRISE RESIDENTS ONLY

- <u>Submission for the Sunrise Resident lottery ends Friday, April 3.</u>
 Registrations received by April 3 will be randomly selected and assigned a camp location according to choices selected on the registration form.
- Completed registration forms must be received by Friday, April 3, at 5:30 pm in the Leisure Services Office.
- Forms received after April 3 will be processed in the order they are received, space permitting.
- Assignment lottery begins Monday, April 6, for City of Sunrise residents.
- Registration verification will be available by phone on Tuesday, April 21.
- Selection of more than one camp choice is HIGHLY recommended, in the event a school site becomes unavailable for summer camp use or is full at the time of registration.
- Dates and locations are subject to change based upon School Board approval.

NON-RESIDENTS (including children who attend a Broward County Public School located in Sunrise but live outside of the City of Sunrise)

- Submission for the Non-Resident lottery ends Friday, April 17. Registrations
 received by April 17 will be randomly selected and assigned a camp location
 according to choices selected on the registration form.
- \bullet Completed registration forms must be received by Friday, April 17, at 5:30 pm in the Leisure Services Office.
- Forms received after April 17 will be processed in the order they are received, space permitting.
- Assignment lottery begins Monday, April 20, for Non-Residents.
- Registration verification will be available on Tuesday, April 28.
- Selection of more than one camp choice is HIGHLY recommended, in the event a school site becomes unavailable for summer camp use or is full at the time of registration.
- •Dates and locations are subject to change based upon School Board approval.

HOW TO COMPLETE A REGISTRATION FORM:

- Go to the registration form located in the back of the Horizons magazine or online at www.sunrisefl.gov/camp.
- Completely fill out the information located at the top of the registration form.
- Completely fill out participant's name, date of birth, current grade, age, and gender.
- Select three camp choices (using name and activity#) and list them in
 order of preference. (It is very important that you list three choices as our
 camp programs are popular and fill up quickly.) If your first three choices have
 reached maximum enrollment before your registration is processed, we will
 place you on waiting lists for those three sites only and return your payment.
- Completely fill out emergency contact and authorized pick up person(s) information.

- Parent or legal guardian must sign waiver on the back of the registration form.
- Complete credit card information (including CVV) or attach payment with the registration form
- No online or fax registrations will be accepted for summer camp.

A COMPLETE REGISTRATION INCLUDES:

- Fully completed registration form (Incomplete registrations will not be processed until all information is received).
- Proof of residency must be current as of March 2020

- Copy of each participant's birth certificate (even if you've submitted a copy in the past).

HOW TO SUBMIT YOUR CAMP REGISTRATION:

- Only one household's registration form per envelope will be permitted. (Exception - If you have more children in your household than registration lines on the form, please use an additional form and send them in the same envelope.)
- \bullet Do not include other program registrations with summer camp application.

Site Transfers

In order to expedite the registration process, and allow families to secure child-care in a timely manner, we will only offer one site transfer per participant (i.e. one call to offer a transfer to a first or second choice OR one call to enroll you from off of the waiting list for your first, second or third choice).

Waiting List Information

If you receive a call to transfer or get in a site, you will have three working days to notify us of your decision and/or make your payment or the offer will be extended to the next person on the waiting list.

SUMMER CAMP INFORMATION

Camp Dates: June 15 to August 7 (No camp on Friday, July 3) Camp hours: 7:30am to 6:00pm (Late fees apply after 6:00pm)

Children will experience the best in summer sports, swimming, arts and crafts, and more at our super summer camps. Each camp session features weekly field trips and something for every age group.

Children with a flair for drama should try our special **Theater Camp**. Theater Camp includes script read-throughs, choreography and music, in order to take center stage for their final performance. Includes swimming and field trips!

Children who love to explore how things work will love our **Science and Discovery Camp**. This fun, innovative and exciting program will focus on science and technology.

We will be having two recreational **Sport Camps**: one will be held at Westpine Middle for children ages 8 to 15, and the second will be held at Flamingo Park for ages 11 to 15. Camps will have different program segments. Each one will focus on skill development and games in each sport.

Our Counselor in Training Program (CIT) is designed for our older campers (age 15) either interested in transitioning from camper to counselor or learning what it takes to become a strong and effective leader. Includes swimming and field trips!

Each camper will receive an official summer camp t-shirt. Campers should bring their own lunch and snacks daily. Extra t-shirts can be purchased for \$7.00 each beginning June 17 at the Leisure Services Office.

All camps are staffed by counselors age 16 and older, and an adult supervises each site. Each staff member is trained by the Department of Leisure Services on camp protocol, safety, and recreational programming.

Parents and campers are encouraged to attend an informational meet and greet with the 2020 Summer Camp staff on Thursday, June 11, from 6:00 pm to 7:30 pm at the Sunrise Civic Center gymnasium.

Fees are for the entire eight-week session. Students who currently attend a Broward County Public School located in Sunrise are eligible for the Sunrise resident rate. Proof of attendance verifying enrollment for Spring 2020 must be included with your registration to receive the Sunrise Resident discounted rate. Additional discounts for siblings do not apply to Non-Residents attending Sunrise schools. (One discount per child per family).

Family Discounts for Sunrise Residents

Each additional family member who registers for the same camp program receives a discount, on a sliding scale. For example, participant #1 pays full price, participant #2 pays 10% less, participant #3 pays 15% less than full price, etc. Proof may be requested.

Refund Policy

All refunds must be submitted in writing to Leisure Services Offices (10610 West Oakland Park Blvd. 2nd Floor during the hours of 9:00am-5:30pm). Refunds will be pro-rated from the submission date. Deadline to request a pro-rated refund is Wednesday, July 8 at 5:00pm.

RELEASE AND WAIVER FOR ADULTS AND MINORS

NOTICE TO THE MINOR CHILD'S NATURAL GUARDIAN

READ THIS FORM COMPLETELY AND CAREFULLY. YOU ARE AGREEING TO LET YOUR MINOR CHILD ENGAGE IN A POTENTIALLY DANGEROUS ACTIVITY. YOU ARE AGREEING THAT, EVEN IF THE CITY OF SUNRISE, ITS DEPARTMENTS, EMPLOYEES, OFFICIALS, COACHES, VOLUNTEERS AND AGENTS (HEREINAFTER "RELEASED PARTIES") USE REASONABLE CARE IN PROVIDING THIS ACTIVITY, THERE IS A CHANCE YOU OR YOUR CHILD MAY BE SERIOUSLY INJURED OR KILLED BY PARTICIPATING IN THIS ACTIVITY BECAUSE THERE ARE CERTAIN DANGERS INHERENT IN THE ACTIVITY WHICH CANNOT BE AVOIDED OR ELIMINATED. BY SIGNING THIS FORM YOU ARE GIVING UP YOUR CHILD'S RIGHT AND YOUR RIGHT TO RECOVER FROM RELEASED PARTIES IN A LAWSUIT FOR ANY PERSONAL INJURY, INCLUDING DEATH, TO YOU OR YOUR CHILD OR ANY PROPERTY DAMAGE THAT RESULTS FROM THE RISKS THAT ARE A NATURAL PART OF THE ACTIVITY. YOU HAVE THE RIGHT TO REFUSE TO SIGN THIS FORM, AND RELEASED PARTIES HAVE THE RIGHT TO REFUSE TO LET YOU OR YOUR CHILD PARTICIPATE IF YOU DO NOT SIGN THIS FORM.

I, the undersigned, as the undersigned or as the parent or legal guardian of the minor child ("my child") named below, do hereby give my full consent and approval for me or my child to participate as a member of the City of Sunrise's Recreation Programs.

I understand that there are certain risks of damages and injuries, including death, inherent in the City of Sunrise's Recreation Programs, as well as in traveling and in other related activities incidental to my or my child's participation, and I am willing to assume these risks on behalf of myself or my child. These risks include, but are not limited to, those hazards associated with weather conditions, travel, playing conditions, equipment and other participants.

I understand that there is inherent risk in Recreation Programs and that inherent risk means those dangers or conditions, known or unknown, which are characteristic of, intrinsic to, or an integral part of the activity; and that the term "inherent risk" further includes, but is not limited to: (1) the failure by the Released Parties to warn me or my child of an inherent risk, and (2) the risk that someone may act in a negligent or intentional manner and contribute to the injury or death of me or my minor child.

Further, I agree that in consideration for my or my child's participation in the City of Sunrise Recreation Programs, I hereby waive, release, discharge and agree not to sue the City of Sunrise, its departments, employees, officials, coaches, volunteers and agents ("Released Parties"), for any and all causes of actions, claims or damages arising out of or resulting from my or my child's participation in this activity, including but not limited to damages, injuries, or death arising out of the negligence of Released Parties or otherwise. I agree that for me or my child to participate in the activity, I assume full responsibility for any loss of property, accident, bodily injury, or death as a result of my or my child's participation in this activity.

I hereby permit the City of Sunrise to use or distribute any or all still and/or moving images in which I/my child/my ward appear for any use including, but not limited to: video, Web, print and multimedia applications; training or other instructional materials; advertising, commercials or other promotional materials; and other forms of media, without compensation. Any image (s) created shall be the property of the City of Sunrise.

I hereby give permission for me or my child/ward to receive necessary medical treatment.

I further agree on behalf of myself and my child listed below, that I shall hold harmless and fully indemnify and defend the Released Parties from any and all causes of action, claims, damages, costs including but not limited to attorney's fees and costs, which may arise from any cause of action made by me or by, through or on behalf of me or my child, even if the damages, injuries or death are caused in whole or in part by the negligence of the Released Parties.

I acknowledge (a) that I have read (or have had read to me) each and every one of the provisions in this waiver, release of liability and indemnification agreement, (b) that I understand each of the provisions in this agreement and (c) that I agree to abide by them.
