Application for Approval of Amusement Games

- 1. Per Section 7-88(a) of the Sunrise Code of Ordinances, an owner or operator of a business desiring to use or operate automatic amusement games shall make an application to the Planning and Engineering Department. In addition to the attached application, the application shall include a copy of the proposed floor plan of the business, which shall clearly indicate the amount and location of the proposed automatic amusement games. Twelve (12) copies of the application and floor plan, are required to be submitted along with an application fee, payable to the City of Sunrise (See City of Sunrise Planning and Development Department Fee Schedule).
- 2. The Development Review Committee shall approve the application for automatic amusement games with appropriate conditions and stipulations when it is demonstrated by the applicant that the following criteria are met: (A letter addressing these criteria is required 12 copies).
 - (1) That the business in which the automatic amusement games are proposed to be placed has the facilities to accommodate the use of the machine without disruption to the primary business activity.
 - (2) That the business in which the automatic amusement games are proposed to be placed is not within one thousand five hundred (1,500) feet of a school.
 - (3) That the parking facilities are adequate to accommodate the increased load caused by the users of the automatic amusement games.
 - (4) That an area of the parking lot or close to the business will be set aside for the placement of bicycles, and that proper facilities will be provided.
 - (5) That the parking aisles in the ingress and egress lanes are of sufficient size and design to accommodate the additional traffic caused by the users of the automatic amusement games.
 - (6) That the placement of the automatic amusement games will not in any way present a fire hazard or obstruct ingress or egress to business or aisles, walkways, or doorways of the premises.
 - (7) That an adult attendant will be present on the premises at all times and charged with the responsibility of supervising the use of automatic amusement games.
- 3. The Planning and Engineering Department will review the application and distribute

- copies to the members of the Development Review Committee and said application shall be reviewed at the next Development Review Committee meeting.
- 4. The Development Review Committee shall review the application in terms of meeting the above criteria and shall either approve the application, deny the application, or place such conditions, stipulations, and restrictions on the placement and number of automatic amusement games to be permitted as may be required to protect the health, safety, and welfare of the citizens of Sunrise.
- 5. If an applicant disagrees with the decision of the Development Review Committee, an appeal to the City Commission must be filed in writing within seven (7) days after the Development Review Committee decision. The City Commission shall review the appeal in terms of the criteria established above and shall evaluate the reasonableness of the determination made by the Development Review Committee. The City Commission may override the decision of the Development Review Committee and place conditions and stipulations on the application.
- 6. If your application contains a request for pinball machines (defined as an automatic amusement game which features the use of metal balls as an integral part of the game), it shall be presented to the City Commission for review. The City Commission shall review the findings of the Development Review Committee and take additional testimony as the Commission deems necessary for a fair evaluation of the application and shall, by majority vote, approve the application, deny the application, or approve the application with certain conditions and stipulations.
