## **Meeting Minutes**

#### I. Public Comment

The applicant, developers and DRC members (see attached sign in sheet) discussed comments for the proposed Site Plan.

Mr. Robert Norona, City of Sunrise Gas Marketing & Administrative Manager, reviewed the gas line location. Mr. Markley discussed providing clearance along the south property line.

Ms. Susan Holland, Holland Engineering, inquired about Fire Department Connection (FDC) and hydrant location. Mr. Steve Felicetti, Fire Marshall, advised the applicant team to review the accessibility of the existing hydrants and providing an additional hydrant near the proposed addition. Mr. Felicetti advised that fire lane striping would be reviewed further upon FDC and hydrant locations.

Mr. Brasgalla asked about considerations for the dumpster enclosure relocation. Mr. Jim Koeth, Assistant Director/City Planner, advised the applicant team to review the potential impacts to the existing residential uses by the proposed dumpster enclosure. Mr. Koeth requested the applicant locate the dumpster enclosure in order to minimize any potential impacts.

Mr. Brasgalla reviewed considerations for the proposed southern access along NW 68 Avenue. Ms. Holland advised the church does not propose changing the NW 68 Avenue median.

Mr. Ravindra Ramgulam, Engineer I, discussed aspects of drainage and curbs for NW 68 Avenue. Ms. Holland confirmed the applicant team would look at the functioning of NW 68 Avenue.

Meeting was adjourned at 10:44 a.m.
