Meeting Minutes

I. DRC Minutes from June 5, June 26, and August 7, 2019 were approved unanimously.

The applicant, developers and DRC members (see attached sign in sheet) discussed comments for the proposed site plan.

Kristhian Morales of Thomas Engineering Group, LLC, inquired about comment on parking space depth. Mr. Markley responded that the applicant team needed to confirm the dimensions of the existing spaces. Ms. Ashley Resta, City Engineer, said that all current Land Development Code requirements need to be satisfied.

Mr. Morales reviewed the proposed "car side" service in response to comments to pick-up service. Mr. Markley advised the applicant team to review safety of the operations. Mr. Jim Koeth, Asst. Director/City Planner, said they need to detail the operations. Mr. Jamie Butler of Bloomin' Brands for Outback Steakhouse and Mr. Morales reviewed the elevation renderings and indicated that it was not a good representation. Mr. Koeth requested the applicant re-submit their update for staff to review.

Mr. Morales asked about the southern entrance and the extent of the berm to its west. Mr. Ravindra Ramgulam, Engineer I for the City; Mr. William Byrnes, Urban Forester; and Ms. Resta reviewed design criteria for the applicant team to consider. Mr. Butler discussed their own criteria for design.

Mr. Morales reviewed design alternatives they would review. Mr. Morales also discussed consideration for landscape islands between head-to-head parking.

Meeting adjourned at 10:16 a.m.
