Goals and Objectives

Veteran Advisory Board shall act in an advisory capacity to the assistant city manager. The Veterans Advisory Board shall be advisory in nature only. The Veterans Advisory Board shall have the following duties and responsibilities:

- (1) Provide recommendations to the assistant city manager on projects, programs and initiatives intended to encourage recognition and support of Veterans, Active Duty Personnel, Drilling Reservists and their families;
- (2) Promote and recommend city programs, initiatives and events as they relate to Veterans, Active Duty Personnel, Drilling Reservists and their families;
- (3) Provide recommendations to the assistant city manager on how other City Departments may address issues impacting Veterans, Active Duty Personnel, Drilling Reservists and them families;
- (4) Designate one or more liaison(s) to attend another City Advisory Boards to integrate the needs of Veterans, Active Duty Personnel, Drilling Reservists and their families into KAKRG0506 4 CI5136 underscored words are additions the respective missions of these boards, including, but not limited to the

- (5) Provide a mechanism for public input and help inform the City regarding issues pertaining to Veterans, Active Duty Personnel, Drilling Reservists and their families in Sunrise;
- (6) Develop information regarding available support services and/ or organizations to which Veterans, Active Duty Personnel, Drilling Reservists and their families may be referred;
- (7) Educate the city, city residents, visitors, businesses and employers regarding issues affecting Veterans, Active Duty Personnel, Drilling Reservists and their families;
- (8) Maintain relationships with and seek input from advocacy groups and support groups dedicated to Veterans, Active Duty Personnel, Drill ing Reservists and their families, regardless of the location of the group;

(9) Review and provide input to the assistant city manager on policy, management, rules, regulations, and ordinances related to Veterans, Active Duty Personnel, Drilling Reservists and their families;

(10) Perform such other active ties as directed by the assistant city manager, city manager, or city commission.

(e) Rules of conduct. The Veterans Advisory Board may establish rules for the conduct of its meetings, including order of business. Meetings of the board shall be held at such times as the membership shall determine.

Section 3. Conflict. All ordinances or parts of ordinances, all City Code sections or parts of City Code sections, and all resolutions or parts of resolutions in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 4. Severability. Should any provision of this Ordinance be declared by a court of competent jurisdiction to be invalid, the same shall not affect the validity of the ordinance as a whole, or any part thereof, other than the part declared to be invalid.

Section 5. Inclusion in the City Code. It is the intention of the City Commission, and it is hereby ordained that the provisions of this Ordinance shall become and be made a part of the Code of the City of Sunrise, Florida.
