# **Open Discussion**

### Introduction

Kevin Pickard, Leisure Services Director, introduced himself and welcomed all board members. Each board member was introduced and then spoke a little about themselves. All were happy to attend the virtual meeting and look forward to being a part of the board.

Glinda Townsley made a motion to accept the CMT Rules as written and it was seconded by Aura Abreu. The motion was carried without opposition.

<u>The City's Response to COVID-19</u>- In an effort to stop the spread of COVID-19, the City closed facilities to the public, cancelled programs and operated remotely, asking as many employees as possible to telecommute. Leisure Services shifted its focus to inform residents about available local, state and federal social services resources. Throughout the pandemic, staff members from every division worked within the community, providing a variety of services while maintaining CDC guidelines to ensure public safety.

#### Social Services

- Drive thru Food Distribution- worked with Feeding South Florida, has assisted with 63 events, with and estimated 43,000 meals given away to date
- Compassion Call Center- assisted residents with questions about COVID-19 testing, paying bills, finding housing, etc.
- Assisted the Islamic Foundation with food distribution
- Walmart delivery program- assisted seniors with food deliveries
- o ADRC delivery program- assisted with frozen food deliveries

- Worked with Rotary Club of Weston to provide Sunrise residents with restaurant food and support local restaurant businesses.
- Cares Act Funding- Leisure employees assisted the City's Grants Division in distributing Federal
  and State monies to residents that needed help paying their utility bills, rent and mortgages.

- Tech staff was responsible for the City's virtual commission meetings and filming videos
- Built a large sign in support of all 2020 graduates
- Tech staff are busy building large holiday decorations

<u>G.O. Bond Projects Update-</u> Kevin Pickard shared a few status updates on the projects which continued throughout the pandemic:

 Civic Center Athletic Club renovation was completed and reopened to the public with social distancing protocols in place.

- City Park renovation was completed and is now open. Glinda Townsley shared that she visits the park and it is beautifully done.
- The Senior Center is very close to completion and the plan is to reopen when all other facilities and programs start again.

<u>Future Meetings-</u> Board members shared their views about returning to in person meetings as we work towards returning to pre-COVID operations. All views will be taken into consideration as the City staff awaits a decision to be handed down from the City Manager's Office.
