I responded to 735 SW 148th Ave Apt 1714, Sunrise FL. 33323 reference to a Domestic Disturbance between two daughters. Upon arrival contact was made with Richard Golden, the father of Shayna Golden. Mr. Golden clarified the incident and advised that a verbal argument was occurring between Shayna Golden and her friend [REDACTED] who had been living in the residence for approximately the last 3 to 6 months. Mr. Golden requested that [REDACTED] be removed from the residence.

While speaking with Mr. Golden, the arguing between the two girls could be heard from downstairs. Both myself and Mr. Golden, yelled out to the girls to come downstairs to discuss the matter. However, the requests were ignored and the arguing grew even louder. I then grew concerned about the safety of both girls, as the initial call mentioned items were being broken in the residence and I was fearful that violence could be imminent. I along with my backup officer, Ofc. S. Jenkins then made our way upstairs to help diffuse the situation.

Upon making my way to the top of the stairs, I observed Shayna Golden and [REDACTED] arguing in a bedroom. While walking toward the bedroom, Shayna Golden observed me in a full police uniform with the markings Sunrise Police Department. Shayna then intentionally attempted to close the door in my face in a effort to prevent me from entering the bedroom. Due to the nature of the call and the possibility of violence, there was concern for the safety for both parties being potentially being locked in a room alone together. For this reason, I expedited getting into the bedroom to gain control of the situation and separate both parties. Upon gaining access into the bedroom I attempted to detain Shayna Golden in an effort to physically separate both parties by removing Shayna Golden from the room. However, before I could detain Shayna Golden my efforts were stopped when [REDACTED] intentionally and actively resisted, obstructed, and opposed this officer who was in the legal and lawful execution of his duty as a police officer by blocking and shielding Shayna Golden with her body, standing between myself and Shayna and attempting to swat my hands away. [REDACTED] actions of actively obstructing me, forced me to divert my attention away from Shayna Golden and to focus on [REDACTED] in an effort to prevent her from stopping me from detaining Shayna.

Upon attempting to place handcuffs on [REDACTED] [REDACTED] began to resist my effort to place handcuffs on her, and Shayna assisted in thwarting my efforts, by grabbing onto [REDACTED] in a effort to prevent me from placing handcuffs on [REDACTED]. During the struggling, [REDACTED] and Shayna were both restrained on the bed. Shayna who was laying on her back, intentionally and willfully kicked me with her right leg twice, striking me first on the left side of the head hitting my temple and then kicking me in the chest to prevent me from handcuffing [REDACTED]. It was at this point the decision was made by me to use the department issued OC spray to gain control of the situation. [REDACTED] was then pinned to the mattress with my left hand and a burst of OC spray was deployed into the faces of both [REDACTED] and Shayna Golden. After the OC spray was deployed, both [REDACTED] and Shayna were able to be secured in handcuffs and were removed from the residence. While escorting [REDACTED] from the residence, [REDACTED] acknowledged and uttered that she was intentionally attempting to stop my efforts to detain Shayna. Sunrise Rescue was then contacted to treat both [REDACTED] and Shayna for OC spray exposure. Both girls were then treated by Rescue 83 and Rescue 92 on scene and taken into police custody. Both girls were then transported to Cleveland Clinic Hospital by Rescue 83 and Rescue 92. At Cleveland Clinic Hospital, both [REDACTED] and Shayna were read their Miranda Rights, and both invoked their right to remain silent.

After medical clearance was provided at Cleveland Clinic, [REDACTED] was released to her mother [REDACTED]

Responded to the listed location, along with Officer [redacted] in regards to an unwanted guess on the premises. Contact made with the complaint, who explained the situation regarding his daughter, Shayna Golden, and her juvenile female guest, [redacted]. Officer [redacted] and I made contact with both subjects inside a bedroom of the residence. Upon contact, both subjects immediately became combative. They were yelling, "Get out!", became very erratic, and Ms. Golden held onto [redacted] from behind. Attempts to calm the subjects and separate Golden from [redacted] met with resistance. [redacted] tensed her arms and pulled away from Officer [redacted] Golden wrapped her arms and legs around [redacted] then she tensed her arm and legs and pulled away from my efforts to separate her from [redacted]. Due to the subjects' actions, Officer [redacted] used department issued OC spray to quell the subjects actions. Afterward, I detained Golden in hand restraints. Officer [redacted] detained [redacted] in hand restraints. Both subjects were escorted out of the residence, then placed in our Sunrise PD patrol units until Sunrise Fire Rescue arrived to treat both subject for OC spray contact. Both subject were transported to Cleveland Clinic hospital for treatment. Officer [redacted] later arrested [redacted] and Golden for the listed charges.

<p>I responded to 735 SW 148th Ave Apt 1714, Sunrise FL. 33323 reference to a Domestic Disturbance between two daughters. Upon arrival contact was made with Richard Golden, the father of Shayna Golden. Mr. Golden clarified the incident and advised that a verbal argument was occurring between Shayna Golden and her friend [REDACTED] who had been living in the residence for approximately the last 3 to 6 months. Mr. Golden requested that [REDACTED] be removed from the residence.</p> <p>While speaking with Mr. Golden, the arguing between the two girls could be heard from downstairs. Both myself and Mr. Golden, yelled out to the girls to come downstairs to discuss the matter. However, the requests were ignored and the arguing grew even louder. Concern about the safety of both girls, I, along with my backup officer, Ofc. S. Jenkins made our way upstairs to help diffuse the situation. Upon making my way to the top of the stairs, I observed Shayna Golden and [REDACTED] arguing in a bedroom. I was wearing my road patrol police uniform with Sunrise Police Department markings.</p>

### Narrative - continued

Shayna Golden aggressively paced while staring at my approach towards the bedroom. As I approached the bedroom, Shayna intentionally attempted to close the door in my face in a effort to prevent me from entering the bedroom. Concerned that she could lock the door on me with the other party still in the bedroom, I was forced to enter the bedroom to quickly avoid the situation from escalating further with the objective to physically separate both parties and gain control of the situation. Before I could detain Shayna Golden, my efforts were stopped when [REDACTED] intentionally and actively resisted, obstructed, and opposed this officer who was in the legal and lawful execution of his duty as a police officer by blocking and shielding Shayna Golden with her body, standing between myself and Shayna and attempting to swat my hands away. [REDACTED] actions of actively obstructing me, and forced me to divert my attention away from Shayna Golden and to focus on [REDACTED] in an effort to prevent her from stopping me from detaining Shayna.

Upon attempting to place handcuffs on [REDACTED] began to resist my effort to place handcuffs on her, by physically pushing my hands away. Shayna then assisted in thwarting my efforts, by grabbing onto [REDACTED] in a effort to prevent me from moving [REDACTED]. To avoid [REDACTED] and Shayna from getting hurt and to control their movements, [REDACTED] and Shayna were both restrained on the bed. Shayna who was laying on her back, intentionally and willfully kicked me with her right leg twice, striking me first on the left side of the head, hitting my temple and then kicking me in the chest. The abrupt kick to my left temple momentarily took me by surprise and left me with concern that Shayna would continue to escalate to further violence if the struggle continued. For this reason, I made the decision to use my department issued OC spray to swiftly gain control of the situation. [REDACTED] was then pinned to the mattress with my left hand, despite her attempts to push herself off the mattress, then a burst of OC spray was deployed into the faces of both [REDACTED] and Shayna Golden.

After the OC spray was deployed, both [REDACTED] and Shayna were quickly subdued and were able to be secured in handcuffs without suffering injury and then were removed from the residence. Sunrise Rescue was then contacted to treat both [REDACTED] and Shayna for OC spray exposure. Both girls were then treated by Rescue 83 and Rescue 92 on scene and then transported to Cleveland Clinic Hospital.
