

On 11/03/21 I was dispatched to the listed address in reference to a physical domestic disturbance.

Upon arrival, I met with the offender, later identified as Harlyn Fritz (OF), in the parking lot by his vehicle. Harlyn immediately became aggressive toward officers and stated "Putting handcuffs on me will not be easy!", in addition to advising officers to "stay out of this if you have kids." It should be noted, Harlyn started to pace around, moving his neck back and forth, and clenching his fists. Based on Harlyn's previous comments and physical actions, it was believed that he was getting ready to physically attack Officers. Due to Harlyn's behavior, an additional Officer responded to the scene. While conducting my criminal investigation, Harlyn refused to answer any questions. Harlyn escalated his hostility to Officers and then refused to comply to our verbal commands to sit on the ground after several verbal requests were made.
