• <u>42-2110-043140</u> Resistance to Report

Board watched body camera footage from Officer Douglass regarding shoplifting case.

• <u>42-2111-044984</u> Resistance to Report

Board discussed the body camera footage from domestic case.

Was the girlfriend (victim) checked on or spoken with?
 The video showed the officers talking to the subject and during the
 25-minute video not once did they check or speak with the victim.

She could have been seriously wounded. – The victim was seen by Fire/Rescue and was ok.

What is the training on handling calls with agitated subjects? The video depicted 2 officers dealing with the male subject. The 2 officers should have detained him sooner and went to check on the victim. Training will address it on future training schedules.

Members commended Officer McCarthy on handling the call with the subject.

The Sergeants and Lieutenants views body cameras and probably addressed it with the officer and in briefing.

• <u>21-07-01</u> Internal Affairs Investigation

One issue that was brought up was the retrieval of the video regarding an accident. Why did it take so long for an officer to retrieve the video especially if the video was going to be erased within the next 48 hours?

What was his punishment? The officer was given a written reprimand.

A written reprimand wasn't sufficient enough since he missed clear opportunity to retrieve the video to rule out any thing important regarding the case.

Discussed the different types of reprimands given by the Chief.
