#### G. OLD BUSINESS

# 1. Bike Bingo

The Board presented their recommendations for the Bike Bingo. The City Liaison instructed the Board to email their recommendations to the City so that they are evaluated for inclusion in the Bike Bingo. The City Liaison instructed the Board to rate their ideas and send their top 5. The City Liaison will prepare a template with the top 25 recommendations to be presented at the April Board meeting.

The Board inquired on the status of prizes (cups, stickers, magnets, etc.) for the Bike Bingo, which the City Liaison noted is still in the evaluation process.

## 2. Advertisement in City's Horizon Magazine/ Flyers

The City Liaison informed the Board that advertisement in the City's Horizon Magazine is not available at this time, but will continue to follow up on the request. The City Liaison inquired if the Board had any updates regarding the informational flyers. The City Liaison reiterated that the Board is to prepare a draft of the information flyer and submit to the City for review.

The Board then inquired if the informational flyers may be distributed through schools once approved. Deputy Mayor Guzman responded that the City could provide the School Board copies of the flyer for distribution in their pamphlet after the flyer was approved.

#### 3. Attendance at City hosted events

The City Liaison informed the Board that there is no Board representation at City events for any Boards at this time. The City Liaison noted that an update will be provided at the April meeting. The City Liaison informed the Board that they may currently volunteer at City hosted events, where they may provide information about the Board.

#### H. New Business

The Board inquired about the budget for the Bicycle and Pedestrian Advisory Board (BPAB). The City Liaison stated he will follow-up on the Board's budget at the April meeting.

The Board recommended the installation of a decorative crosswalk sign at the intersection of Oakland Park Blvd and Nob Hill Road in remembrance of the City resident that was hit while riding their bike in the area. The City Liaison acknowledged he would present this idea to the appropriate person. The City Liaison noted that there is currently a project for that intersection and he would evaluate if there is an opportunity to include the request in the scope of work. Deputy Mayor Guzman informed the Board that the

City has requested widening the sidewalk at the Oakland Park Blvd and Nob Hill Road intersection.

The Board provided the map used for the 2022 Tour De Broward to the City Liaison and inquired if they can set up a table to distribute flyers and water to the bicyclists as they pass through the City of Sunrise next year. The City Liaison noted he will follow-up on the request.

Having no more items to discuss, the Board confirmed the next meeting would be held on Thursday April 14, 2022 at 6:30 PM.
