Narrative

During the execution of a Search Warrant for a firearm at the aforementioned location, Torres initially came to the front-door threshold of the residence then quickly retreated into the structure where SWAT operators were unable to maintain a visual. A prior intelligence briefing informed this officer that Torres has an extensive criminal history to include an attempted murder charge. Loud verbal commands were provided requesting Torres to exit the residence and come to my position. Torres exited the residence, initially walking toward my position. It should be noted that Torres was holding his juvenile child in one arm while video taping operators with a cellular device in the other hand. Torres then began walking backward away from me at which time SWAT operators made an approach. Torres was advised that he was to be detained pending further investigation and a pat-down for officer safety. I attempted to place Torres into handcuffs at which time pulled away from my grasp and stated, "You ain't putting no handcuffs on me, let me go!" I attempted to secure handcuffs on his left hand while stating, "Don't move your hand." Torres violently withdrew his hand, swinging the second unsecured cuff though the air in the direct vicinity of SWAT operators. I applied one closed-hand strike to the Torres' face to cease his active resistance and cause temporary disorientation. My strike was effective in compelling the desired compliance so that the remaining handcuff could be safely applied.

Upon the arrival of additional assisting officers, Torres was transferred into their custody and escorted to										
responding Sunrise Fire Rescue personnel for treatment. Torres did not sustain any apparent or claimed injury										
in the presence of this officer.										
Torres was placed under arrest for resisting with violence and transported to BSO Main Jail for further										
processing.

On 11/8/2021, at approximately 8:46pm the Sunrise Police Swat Team executed a residential search warrant at 9001 NW 26th PL Sunrise FL 33322. During the execution of the aforementioned search warrant, the defendant Jimmy Torres (the occupant/homeowner) actively resisted Sunrise Swat Operators by bracing, tensing, pulling away and refusing to comply with their lawful commands. Mr. Torres then states "you ain't putting no handcuffs on me" as attempted to detain him. After placing one handcuff on Mr. Torres left wrist he then began to actively in attempt to prevent him from being resist by flailing his arm towards officers and pulling away from detained.

It should be noted that while his one hand were cuffed, Mr. Torres knowingly and intentionally swung the cuffed arm towards officers, almost striking them with the opposite end of the opened handcuff.

It is my belief that Mr. Torres did knowingly and willfully resists, obstruct and oppose s lawful commands and by doing so did violently resist all attempts to take him into custody.

Mr. Torres was ultimately subdued and placed under arrest for resisting with violence. After receiving medical clearance, Mr. Torres was transported to BSO Main Jail.

BWC footage was recorded and uploaded by the Sunrise Swat Team.

This Detective believes Mr. Torres did actively resisted Sunrise Swat Operators by bracing, tensing, pulling away and refusing to comply with their lawful commands.

This case is being sent to the SAO for final review and disposition.

This case is Pending Active awaiting SAO approval for charges.

On Monday, November 8th, 2021, I observed the following while operating in a SWAT capacity:

During the execution of a SWAT search warrant, I observed Jimmy Torres exit the residence at 9001 NW 26th Place. Torres was provided loud verbal commands to proceed to the position of SWAT operators for temporary detention. At this time, Torres began actively resisting lawful detention by pulling away from 's grasp and preventing handcuff's from being secured on his person. Torres stated, "You ain't putting handcuffs on me. Let me go." secured one handcuff on Torres' left hand stating, "Don't move your hand." At this time, Torres swung his left arm away while swinging the second unsecured handcuff through the air in close vicinity of SWAT operators. I apply one closed fist strike to the face of Torres. momentarily disorientating Torres and ceasing his active resistance. I did not observe any additional strikes being applied to Torres, who was subsequently secured in the remaining handcuff without further incident.

Upon the arrival of additional assisting officers, Torres was transferred into their custody and escorted to responding Sunrise Fire Rescue personnel for treatment. Torres did not sustain any apparent or claimed injury in the presence of this officer.

The SWAT operation continued without further incident.

Torres was placed under arrest for resisting with violence and transported to BSO Main Jail for further processing. See supplement from Detective Deltamus Cason for further.

This concludes the extent of my involvement in this investigation.
