Broward County Communications received a 9-1-1 from Factorian stating that he had been hit with a baseball bat by his son, Karl Nilsen. told dispatch that he was currently in his bedroom with his wife and that Karl had returned to his room.	1
Upon Officers arrival on scene, exited through the front door and met with Officers. Shortly after, and Marzouca entered the home and went directly to Karl's bedroom. Officer M. White remained outside with Once inside, they found Karl armed with at least one large kitchen knife. Officers provided numerous commands to drop the knife but he refused. This was confirmed by his mother, during her sworn statement. Then deployed his Taser but it was proven unsuccessful. Next and fired several gunshots striking Karl. Officers immediately started CPR and requested Rescue. Karl was pronounced dead on scene at 10:32pm by Sunrise Fire Rescue.

Broward Sheriff's Office Detectives and Crime Scene were contacted and requested to respond to the scene, to conduct the investigation. BSO Detective Brian Tutler served as the lead investigator and conducted the criminal investigation.

On September 17 th , 2021, Sunrise Police Department received notice from the Broward County State Attorney's Office, that there would be no charges brought against and
Pursuant to Sunrise Policy & Procedure 35.6.11.2.3.1, I conducted an administrative investigation into the incident. I reviewed the entire case file and spoke with Detective Tutler. I also reveiwed the August 3 rd , 2018, Response to Resistance Reports (RRR) completed by Detective Lowenstein. The first RRR documented the ineffective discharge of RRR was for the discharge of and assigned Glock firearms during the incident. I obtained copies of their firearm/Taser qualification sheets reflecting a successful qualification with the said firearms/Taser consistent with the regulatory guidelines.

CASE SYNOPSIS:

On Friday August 3rd, 2018 at approximately 10:12 p.m., Sunrise police officers responded to Sunrise in reference to a 911 call (placed at 10:09 p.m.) of a domestic violence incident involving an adult male attacking his parents with a baseball bat. Multiple officers arrived (initial arrival at approximately 10:15 p.m.) and established contact with the decedent's father, who confirmed that he had been struck in the torso with a baseball bat by the decedent (his son) and later the decedent's mother. Sunrise PD officers entered into the residence and attempted to place the decedent in custody for safety / arrest. After making entry to the decedent's bedroom, the two listed Sunrise PD officers observed the decedent to be armed with a knife / knives. Despite verbal commands to drop the knife / weapon (confirmed in sworn statements by witness LEOs as well as the decedent's mother), the decedent refused. The officers then attempted to utilize a Taser. Subsequent to an unsuccessful Taser deployment, officers fired several gunshots utilizing their firearms. Shots were fired at approximately 10:20 p.m., and officers immediately requested back-up as well as Fire Rescue units to respond. CPR began and was advised to have begun over the radio at approximately 10:23 p.m. The decedent was pronounced deceased by Sunrise FD (run # 9131) Firefighter Wezkiewicz at 10:32 p.m.

Two officers (Marzouca and White) who did not fire gave sworn recorded statements. Civilian recorded sworn statements were obtained from the decedent's parents and revealed that the decedent's mother was in the residence at the time of the shooting and heard the officers telling the decedent to drop his weapon(s). Follow-up investigation revealed that the decedent had severe mental issues and that the decedent was armed with at least one large kitchen knife during the shooting (knife likely struck and broken by a projectile). The crime scene, decedent's weapon, located evidence and witness statements initially supported one another and continued to do so throughout the course of the investigation. The decedent was transported to the Medical Examiner's Office pending Post-Mortem exam. A Post-Mortem exam also supported the investigation. The Medical Examiner ruled the victim's death to be a Homicide.

NARRATIVE SECTION:

On Friday August 3rd, 2018 at approximately 11:02 p.m., Broward Sheriff's Office (herein referred to as BSO) Homicide Unit Detective-In-Charge Kevin Forsberg # 13537 requested that I respond to 9 city of Sunrise in reference to a Sunrise Police Department (herein referred to as SPD) officer involved shooting that occurred at approximately 10:20 p.m.

At approximately 11:38 p.m., I arrived on scene and observed numerous marked SPD patrol units with their emergency lights activated as well as numerous unmarked units parked along NW 24th Court. The crime scene was secured with yellow crime scene tape and guarded by numerous SPD police officers. I would subsequently meet with command and investigative personnel including Homicide Supervisor Detective-In-Charge Kevin Forsberg for the purpose of receiving an initial briefing of events. Detective David Lowenstein and would inform me the account of events listed in the case synopsis. During this initial briefing, I was assigned as Lead Detective in this case. Of note during the initial briefing was that there was one deceased person on scene, identified as decedent Karl Nilsen. The initial on-scene witness statements, 911 calls, and radio transmissions revealed that Nilsen was involved in an aggravated battery related incident where he had attacked his parents (decedent's) at their residence and that the shooting occurred at approximately 10:20 p.m. (approximately eleven minutes after the 911 call placed at 10:09 p.m. to report the armed / aggravated battery incident placed by the decedent's father). I was then informed that two on-duty law enforcements officers from the SPD were involved in the officer involved shooting after they had reportedly confronted an armed and uncooperative Nilsen during their response to the incident.

BSO Homicide Detective Zack Scott was tasked with taking statements from civilian witnesses (decedent's parents) and informing them of the investigative process as they are the decedent's next of kin. SPD detectives (listed in the LEO witness section of this report) were tasked with area canvassing, taking statements from any located civilian witnesses, and coordinating any potential surveillance video downloads / evidence collection. Crime Scene Detectives including Clint Williams were also on scene preparing for their investigation. BSO Homicide Detective Phillip Reynolds and Crime Scene Technician Kim Woodward were tasked with responding to the SPD main office for the purpose of round counts / witness statements with SPD officers who were involved in the shooting death of the decedent. Round counts were also taken at the shooting scene of the witness deputies who were present at the scene but did not utilize their firearms (Refer to the original and supplemental event reports filed under this case number for a detailed first-hand account of all SPD Road Patrol Officer / Sergeant / Detective involvement in this case as well as all BSO Homicide and BSO Crime Scene supplemental reports relating to the crime scene / area canvass and round counts / photographs of all law enforcement on scene).

**** Note that SPD Detectives conducted an extensive area canvass over the next several days. No surveillance video / cell phone video depicting even the general direction of the residence where / when the shooting occurred was ever located (shooting also took place inside of the decedent's residence). Approximately 24 statements were taken from people in the area (all 24 listed in the civilian witness section) who could have possibly observed the shooting. None of these witnesses personally observed the shooting or events surrounding the shooting. Several heard possible gunfire and observed police vehicles / activity outside of the decedent's residence. Refer to the supplemental reports authored by Sunrise Detectives Lowenstein, Gindlesperger, Wilds & Rodriguez as well as the statement transcriptions for details regarding these witnesses' accounts of events relating to how they did not personally witness the shooting.

**** Note that the investigation / law enforcement & civilian witness statements / round counts / physical evidence would ultimately reveal no evidence other than that SPD were the only law enforcement personnel on scene to fire their weapons.

On Saturday August 4th, 2018 at approximately 12:26 a.m., I conducted a sworn digitally recorded statement with listed law enforcement witness SPD Officer Mark Marzouca. Officer Marzouca stated that he was working in his duties as a Sunrise Police Officer and utilizing a marked patrol vehicle / wearing a Sunrise PD Road Patrol uniform on the date of August 3rd when he was dispatched to the call at the decedent's residence. Officer Marzouca stated that the call was advised to have involved a father who was struck with a bat by his son and that the son was "currently in his room." Officer Marzouca stated that other SPD Officers were dispatched to the call as well.

Search Warrant I authored for the residence located at an approved by Homicide SAO ASA Lanie Bandell at 2:43 a.m.). This residential Search Warrant was later clerked in at the Broward County Clerk's Office and assigned warrant number 18-0943SF10.

At approximately 4:20 a.m., the Search Warrant was served and Crime Scene detectives and I began the physical scene / decedent's body investigation. The Crime Scene search / Search Warrant service would last until approximately 9:45 a.m. BSO Crime Scene Detective Clint Williams and Crime Scene Unit Sergeant Joseph Poliard were already busy with this scene investigation. Firearm related evidence, scene evidence and decedent body related evidence recovered / observed during the scene investigation can be described as including (but not limited to):

Living room / hallway / bathroom area just outside of decedent's bedroom (includes but not limited to): broken decorative items, numerous broken glass encasements, broken glass strewn throughout, nine spent Hornady brand .40S&W shell casings positioned in the hallways and doorways / bathroom outside of the decedent's bedroom, Taser probe wires, vertical blood droplets tracking between the decedent's bedroom and the kitchen, and an X2 Taser serial number X29005PK1 with one spent cartridge and one live cartridge positioned in just past the threshold of the bathroom door adjacent to the decedent's bedroom.

Inside of the kitchen / TV room area (includes but not limited to): vertical blood droplets tracking to / from the decedent's bedroom, broken windows, broken glass strewn throughout, a broken TV, blood transfer / droplets on the kitchen counter, floor and cutlery drawer, and a knife in the cutlery drawer also containing a knife with blood transfer.

The smell of putrefaction was not present and there was no insect activity.

Gunshot wounds were observed on both of the decedent's hands, the decedent's left bicep, the decedent's torso / chest, the decedent's neck and two possible exit wounds in the decedent's back. The decedent suffered what appeared to be radiating wounds consistent with a projectile striking an intermediate object in front of his torso (possible knife destroyed by a projectile). The decedent had a single Taser probe dart affixed to his chest. (All gunshot evidence was consistent with wound trajectories discovered during the decedent's autopsy). sustained at least 10 gunshot wounds, including both penetrating and perforating wounds involving possible re-entry wounds from the same projectile as well as projectile fragments. None of the wounds indicated close contact / stippling.

Three of the gunshot wounds were perforating, with the projectiles being recovered inside of the decedent's body. These wounds were sustained by the decedent in the torso, left arm and right thumb. Six gunshots wounds were penetrating, sustained by the decedent in his neck, torso and right hand. A gunshot wound to the decedent's left hand was also observed and damaged multiple parts of the left hand / fingers. The wound pattern appeared to be consistent with the decedent possibly holding an item (fist partially clenched) at the time of the shooting. The trajectory of all rounds were from the front of the decedent and towards the decedent's left side (no entry wounds to the decedent's back). These trajectories were consistent with witness statements and the recovered scene evidence. Several projectiles and projectile fragments were recovered during the autopsy.

Dr. Sneed documented each injury and each step of the examination was documented and photographed. See Dr. Sneed's autopsy report for further details regarding the examination of the decedent, areas of gunshot wound trauma, specific wound paths of travel and trajectories, and a list of subsequent tests and preserved specimens. All ballistics evidence / DNA standards were taken and later transferred into the possession of Crime Scene Technician Kim Woodward.

At the conclusion of the autopsy, Dr. Sneed ruled the cause of the decedent's death to be multiple gunshot wounds and the manner of death was ruled a Homicide. Toxicology results would later reveal the presence of Citalopram (a.k.a. Celexa) (0.14 mg/L) in the decedent's bodily fluids.

On Monday August 6th, 2018 at approximately 7:00 p.m., I discovered that the decedent's mother had given an interview to South Florida new station WSVN7. The interview and article were later posted on the internet for public viewing. I downloaded a copy of the interview and saved the recording to a disc (later placed into this case file as evidence under this case number) to determine if the interview was consistent with the sworn statement obtained from in the early morning hours of August 4th. The TV interview was consistent with her statement. During the news segment, the reporter indicates that "is not mad at the officers." atter states in the interview that police entered into the residence and made forced entry in the decedent's bedroom. then states that she heard the officers state "drop your weapon." explains that the weapon was a bat and that the decedent would not drop the bat, at which point "they shot him several times."

On Monday August 20th, 2018 at approximately 4:00 p.m., I met with SPD Training Officer William Velazquez and conducted a Taser download on Taser utilized by during the shooting incident. The X2 Taser (serial number X29005PK1) was found to have been fired at the scene based on multiple aphids being recovered along with both cartridge blast doors. As previously described, one Taser probe was found on the ground and the other was found lodged in the decedent's chest. The Taser download confirmed that as required at the beginning of his shift. Relative to the shooting, the Taser was activated at 10:17:19 p.m. and the trigger was depressed at 10:18:04 p.m. (shots fired between approximately 10:19 p.m. and 10:20 p.m.). The download also revealed that there was an ineffective Taser strike, indicative of a single probe contact. The Taser reports were added to the case file and will be put into evidence under this case number at the conclusion of the entire investigation.

NARRATIVE SECTION

On August 4th, 2018 at approximately 11:00 PM, I was directed by Detective-In-Charge Kevin Forsberg to respond in the city of Sunrise in reference to an Officer-involved shooting.

At approximately 11:55 PM, I arrived at the location. I made contact with Detective Bryan Tutler of the BSO Homicide Unit, who had been assigned as the lead investigator on the case. Det. Tutler explained that the shooting had occurred when officers belonging to the Sunrise Police Department had responded to the residence in reference to a disturbance call for service. During the subsequent confrontation with responding officers the decedent, identified as Karl Nilsen, had been shot several times and was pronounced deceased. At the request of the Sunrise Police Department (SPD), BSO's Homicide unit would be conducting the homicide investigation. Det. Tutler identified two civilian witnesses that lived in the same residence as the victim, and requested that I take a sworn statement from them.

On August 5th, 2018 at approximately 12:34 AM I took a sworn recorded statement from vehicle in front of the residence. is the father of the decedent, and had called 911 initially. In his statement, He advised that he and his wife had just completed having sex when they heard glass breaking and loud noises coming from the living room area of the home. the house. He stated that he walked into the living room and kitchen area and observed what he believed to be pieces of broken glass on the floor. tated that his wife, identified as , went into the living room first and began yelling at their son while he tried to locate a pair of shorts to put on.

stated that when he walked into the living room, he observed his son holding a small aluminum baseball bat. He stated that he owns two of these bats, one of which he keeps in the garage, and the second he keeps in his bedroom. He believed that the Decedent had taken the bat that was normally in the garage. stated that he attempt to calm his son down and his son responded by striking him on the left side of his torso with the bat. He showed me his left side where I observed a linear abrasion that was red and swollen. I also noticed that he appeared to have trouble stated that he attempted to strike him a second time with the bat, but he was catching his breath as he spoke. stated that his son then raised the bat to strike for a third time before saying something able to dodge the strike. like "You're not worth it." Before turning and walking to the east end of the residence and into his bedroom.

If he could remember if his son was saying anything while striking him with the bat, and he stated that he thought he was saying something about not having his freedom. I asked him if his son had shut his door to his bedroom, and he stated that he could not remember. I asked him if his son still had the bat with him when he went to his room, and he stated that he could not remember. advised that he went to his bedroom and attempted to console his wife while also calling 911 on his cell phone. I asked him if he remembered what he told the 911 operator, and he stated that he remembered telling them that their son had struck him with a baseball bat, and that "He's going nuts and you need to get somebody out here."

stated that a short time later he could see lights in his driveway, so he exited his residence and observed SPD officers at the base of his driveway. He stated that he remembered telling the officers that his son was in his room, and that he had been struck with a bat. He stated that they asked if his son had any other weapons, and he told them

that the bat was the only weapon he knew of. I asked him if his son owned any firearms, and he stated that he did not. I asked if he owned any firearms, and he said that he did. stated that after calling 911 he remembered that he had left a handgun in the garage. Concerned that his son may have located the firearm while retrieving the bat, he went to the garage, located the handgun, and placed it in his pocket to prevent his son from accessing it. I asked him if he remembered his son ever having any knives or swords in his room, and he stated that he did not recall seeing any when he went in the room.

stated that he remained outside with one of the SPD officers while other officers entered the residence. He stated that a short time later he heard four gunshots. I asked him if he had heard anything before the gunshots, and he stated that he thought he had heard the officers yelling, but did not hear his son yell anything. He stated that a short time later an ambulance arrived on scene, and when it remained in place without removing his son from the residence, he knew that he had died.

about his son's history, and if he suffered from any mental illnesses. He stated that his son had been held under the Florida Baker Act at least twice in the past, the most recent of which was eight months prior. that the decedent also suffered from severe social anxiety, and was bi-polar. He stated that his son had previously lived with his sister approximately two years ago, but had been involved with an incident in which he threatened her that resulted in the decedent being arrested. He believed that his son was prescribed some medications for his issues, but that he was also self-medicating with alcohol.

stated that the argument that evening was the result of an ongoing dispute regarding his son's night time stated that his son would sleep throughout the day and then stay awake all night. On many occasions he would cook very odorous foods, to the point where his parents had purchased him a hot plate to cook in his bedroom. stated the previous evening his son had cooked a large amount of jambalaya in the kitchen, which they had asked him not to do. While his son slept, threw away all of the food. I asked him what he thought his son would do if the police went into his son's room given his mental state that evening, and he stated "Well the state that he was in he would've probably been pissed." Refer to s transcribed statement for further details.

At approximately 1:06 AM, I took a sworn statement from in my vehicle parked in front of the is the mother of the Decedent and the wife of been getting ready to go to sleep with her husband in their bedroom when she heard the sound of glass breaking coming from the living room. She left her bedroom and observed her son standing in the living room with a small aluminum bat in his hand. She stated that then began to argue with the Decedent, and that the two of them have "anger issues." She then stated that her son is Bi-polar and has a "Skewed version of reality." that she remembered SPD Officers arriving on scene and going to the Decedent's bedroom, and that she heard one of the officers say "Drop your weapon" followed by the sound of several gunshots.

I asked to go back and began asking her for further details about what she had witnessed. I asked her to describe what her son looked like when she saw him holding the bat. She stated that her son was holding the bat up in "Swing mode", and that she believes he struck her husband. I asked about the Decedent's mental health history, and she also stated that he had been previously held under the Florida Baker Act. She advised that he had been receiving counseling at Archways Mental Health and Henderson Mental Health. She stated that her son was prescribed medications for his conditions, but was not sure what specific medications he had been prescribed. She also believed

I asked her about where she was when the police arrived at the residence, and she stated that she remained in the master bedroom on the west side of the residence. She repeated that she heard officers telling her son to put the weapon down, but did not hear her son at all. I asked her what she thought her son's response would have been when the officers entered his bedroom, and she stated that "When he has a psychotic break he is gone." Refer to transcribed statement for further details.

were transported by Sunrise Fire Rescue to the hospital to be medically evaluated due to Both their injuries and the physical stress of the event.

At approximately 4:20 AM, I assisted crime scene personnel and other investigators with the execution of a search warrant for the residence.

At approximately 8:30 AM, I responded to the Broward County Medical Examiner's Office to attend the postmortem examination of the Decedent. The examination was conducted by Associate Medical Examiner Wendolyn Sneed. I observed that the Decedent was inside a sealed body transport bag, with seal number 067977 still intact. Dr. Sneed documented numerous entry and exit wounds, and was able to recover several projectiles as well as projectile fragments. In addition to these firearms - related injuries, I observed a single Taser probe lodged on the Decedent's sternum. There were no other Taser - related injuries observed, indicating that only a single probe contact appeared to have been made. This was consistent with the physical evidence discovered at the scene. The examination was documented through photography, and all evidence items were transferred to the BSO Crime scene until for further processing. Refer to Dr. Sneed's Autopsy report for further details.

On August 16th. 2018 at approximately 3:04 PM I attempted to conduct a forensic download of the Taser device recovered from the crime scene (Serial number X29005PK1). Due to the device being registered under the Sunrise Police Department's Evidence.com database, the download was unable to be done. I returned the device to Detective Tutler.

This concluded my involvement in this investigation.
