On 2/12/2022 I responded to a vehicle accident at 6400 W Oakland Park Blvd. The female driver, advised the reason she got into the crash was because an unknown male, later identified as Frantz Jean Baptiste, (described as a black male with shoulder length deadlocks and bright blue shirt) was chasing her vehicle on foot while punching her vehicle windows and she was attempting to drive away from him.

further explained that prior to the crash she was in the liquor store (6254 W Oakland Park Blvd) when the male began yelling at her and said "you look like you got money buy me a beer bitch". Stated the male was kicked out of the store by the staff but then waited outside for her. As exited the store she noticed Frantz was still outside yelling profanities at her. was afraid, got into her car, and drove away. She stated the male ran after her car, punching it as she drove away from the liquor store to a traffic light at NW 64TH AV/W Oakland Park Blvd stated that she was now stopped at a traffic light and blocked in by other vehicles that were also stopped at the traffic light. While she was inside of her vehicle at the traffic light, Frantz began to strike the windows of her car. Stated she was in fear of the male harming her. She stated that she was in such fear that she began to accelerate, striking the vehicle that was stopped in front of her. Stated that after the crash, Frantz fled the seen. She stated that there was minor property damage sustained on both vehicles. Two independent witnesses verified her story. Both witnesses stated they watched Frantz chase 's vehicle while punching her windows.

I attempted to investigate the contributing factor in the crash which was Frantz Jean Baptiste actions which led to the accident.

While investigating, I observed Frantz who matched the description provided by and both independent witnesses in front of Advanced Auto Parts. I approached Frantz along with the assistance of and Officer I asked him what happened at the liquor store and he said "Don't come to me and ask me bullshit questions" and became very irate and argumentative with officers. Due to the highly populated area and Frantz aggressive mannerisms I attempted to detain the Frantz for Officer safety purposes and further investigation. Frantz then made an attempt to open hand strike my arm with the back of his hand and pushed me with an open hand to my chest area. Officers and escorted the subject to the ground. During this time the subject attempted to close fist strike C but then opened his arms and wrapped them around Officer

Frantz was escorted to the ground when he began kicking both of his legs and kicked me in my left knee causing injury. Frantz continued to resist arrest by tensing, pulling away from officers and refusing to place his hands behind his back. Several commands were given to Frantz to stop resisting which were all ignored. I struck Frantz in the side of the stomach and the outter thigh in an attempt to gain compliance. After a brief struggle, Frantz was handcuffed and placed in the back of my marked patrol vehicle #838.

Frantz began kicking my door until the door began to permanently bend. It should be noted that this caused permanent damage which will likely result in the door needing replacement. Frantz also kicked out the middle section of my vehicle's cage which caused unrepairable damage.

Frantz was asked multiple times to identify himself however, he did not cooperate. Officers attempted to use a fingerprint scanner to identify Frantz but were unsuccessful due to his failure to comply. (Frantz name and date of birth was discovered when he later arrived at BSO main jail for processing).

While moving Frantz to a different marked vehicle due to my vehicle now being out of service, I explained to Frantz that he was being trespassed. He replied by saying he was going to go back anyways and he would kill officers with his bare hands and take all the officers to the morgue. He also threatened to shoot officers and our families when he gets out of jail.

Frantz was transported to BSO main jail.

I filled out and filed Risk Protection Order paperwork for Frantz.

A Response to Resistance Form was also completed.

On February 12th, 2022, I responded to 6390 W Oakland Park Blvd in reference to a vehicle accident that just occurred. Upon arrival, I made contact with Ofo who was already on scene. She advised an unknown black male chased a woman, who was later identified as out of a liquor store located on 6254 W Oakland Park Blvd. Once contact was made with the shirt with short dreads and was last seen at 6254 W Oakland Park Blvd. At this time, myself and initiated a canvass for the surrounding area. Shortly thereafter, was able to positively identify a black male subject who matched the description provided by walking in front of 6390 W Oakland Park Blvd (Advanced Auto Store).

While speaking with the male, he was profusely sweating, very uncooperative, and argumentative with officers. He stated to officers "Don't ask me about that bullshit". Due to the highly populated area and the subjects aggressive mannerisms, attempted to detain the subject for officer safety and for further investigation. The suspect then made an attempt to open hand strike "s arm with the back of his hand while she tried to detain him. Myself and grabbed the male and guided him to the ground. He was given lawful commands to stop resisting, but continued to tense and pull. One handcuff was placed on the male's left arm, and he was turned over to his stomach. The male was given commands to release his right arm from under his body, which he refused to comply. At this time I delivered two knee strikes to the male's lower abdomen, causing him to remove his right arm from under his body and was successfully handcuffed.

While still on the ground, the male continued making statements that he would "kill" officers for what they were doing to him. Officers picked the male up off the ground and escorted him to a marked Sunrise Police Car. While trying to get the male in the back of the police vehicle, he made attempts to spit on officers. The male was successfully placed in the back of the vehicle. While the male was in the back of the vehicle, he continuously kicked the door and cage to Ofcomposition vehicle, causing the cage to break and permanently bent the door. The male continuously repeated that he was going to kill officers and he didnt need a gun to do it.

Ultimately, I transported the male to BSO main for processing. While transporting the male, he continuously stated he would kill me the next time he saw me. Upon arrival to BSO main jail, the male had yet to identify himself and be identified. BSO intake Sergeant was able to identify the male via fingerprint scan as Frantz Jean-Baptiste, DOB 09/28/1980. Baptiste was processed with the jail, and completing my involvement with the case.
