Cons: can be distracting. Less private. Not suitable for introverts. Inflexible to task. Prone to illness.

Corey – Airbnb his home and he said his guests teleworks from home and uses the Co-Space when necessarily.

Corey is giving the Co-Space presentation & invited Carl, so the Board can start thinking of it.

Carl shared his experience. He uses a coworking space – "Her Power Space - Coworking & Business Events". He works in the shared space, which is good for networking. And there are some private offices as well. Corey explained you can even receive your mail there. You need to notarize a document, they might have a notary available. You can rent the space as needed, there are many types of plans (daily, weekly, monthly, etc.).

Roberta wants to know how we get them here in Sunrise. Danielle explained we are potentially working on it and we will discuss at the next meeting. The City has been talking about this. It's a trend and it will grow.

We will add to the agenda for next meeting.

Natalya wanted to know how Carl decided to work in a coworking space. He said during the pandemic, he was paying for rent for 9 months without stepping in his office. So he met his friend at a coworking space and after seeing it, he decided to make the change.
