E. APPROVAL OF JUNE 8, 2022 SUMMARY MINUTES

Motion was made and carried to approve the June 8, 2022 summary minutes. Sonia Sierra made a motion and Corey LeGrand seconded the nomination. There was no opposition from the board.

F. OLD BUSINESS

a. Coworking Spaces

Corey further discussed his coworking space presentation. Natalya explained that she was able tour Carl Cyrius coworking space.

Danielle explained that the City has been acquiring property on Sunset Strip and provided a map of the area. A new Art Plaza will be built. The City is negotiating to rent a bay to a brewery. The City is also working on drafting an Request for Interest (RFI) for coffee shops.

The City has had conversations with different operators regarding coworking vs incubator spaces. The City is still discussing the different location options for a future coworking/incubator space.

Roberto inquired about a layout design for the coworking space. Danielle explained that the City would have to partner with a developer for a redevelopment project or an expert to suggest layout ideas.

Cory asked if the City would consider manned or unmanned supervision of the facility. Danielle explained that the city would have to look into that. It would most likely me manned due to safety reasons.

A consultant will make a presentation to the Commission on potential redevelopment vs reuse of city-owned properties across the street from City Park. The Commission will than direct staff on how they would like us to proceed. The City will than most likely partner with a developer to deliver the project as envisioned.

Natalya suggested for Broward Collage to occupy one of the spaces in the new redevelopment plan.

Corey suggested to survey the neighborhood to get feedback on bringing a brewery to the area and to discover what the community wants in the area. Danielle explained that there were lots of public engagement during the master plan process. Part of the negotiations with the brewery would be for them to host a certain number of community events at the Art Plaza.

Danielle explained the goal for the brewery would be to create a vibrant gathering space for the neighborhood, bring in outside businesses, and improve the area.

The East Sunrise Improvement Master plan had a lot of input from the community. The Masterplan is available online.

Michelle Talbert is the founder of Her Power Space which she provided information on how she started her business and successfully got through COVID. Michelle's goal is to franchise Her Power Space over the Country.

Her Power House gives people the opportunity to book an office space or conference room. Customers are able to pay by using the pay as you go option. Her Power Space offers both coworking and incubator spaces.
