D. REVIEW AND APPROVAL OF MINUTES – May 12, 2022

Mr. Leiner motioned to approve the minutes. Seconded by Mr. Barnett. There was no further discussion. All were in favor.

E. OPEN DISCUSSION

There were no members of the public or City present at this meeting who wished to speak during open discussion.

F. OLD BUSINESS

The City Liaison began the meeting by informing the Board that they would not finalize the Bike Bingo template at this session and that the required items to complete the Bike Bingo template will be available at the next BPAB meeting.

The City Liaison reminded the board that representation was not available at City events at this time.

The Board requested that pickle ball courts be provided at City park facilities. The City Liaison informed the board that he will investigate the request and follow-up with the Board.

The City Liaison notified the Board that there was no update related to the dog waste receptacles throughout the City and that an update will be provided once available.

G. NEW BUSINESS

The City Liaison informed the Board that the roadway improvements project along Weston Road, which includes the addition of bike lanes, is ahead of schedule and should be complete sooner than expected.

The City Liaison informed the Board that the pre-construction meeting was held for the Sunrise Gardens project. The City Liaison noted that as part of this project there will be improvements within the right-of-way. The board inquired about the Amazon project, to which the City Liaison noted that there is no application with the Community Development Department at this time.

The City Liaison informed the board there will be new roundabouts and speed humps installed throughout the City as part of various traffic calming projects to be completed by the City's Public Works group.

H. Board Forum

The Board informed the City Liaison that when the trees along NW 44th Street are trimmed, the trimmings are thrown onto the bike path and obstructs the use of the lane. The City Liaison acknowledged that he will inform the appropriate City staff and follow-up with the Board. The Board complimented the City's Clean Team on actively being out within the community and keeping the environment clean. The Board also informed the City Liaison about a water ponding concern near the speed humps along NW 115th Terrace and NW 120th Way and requested an evaluation be done to address this concern.

The Board inquired how many spots are there on the Board and if there are any vacancies. The City Liaison informed the board that there is currently one vacancy due to a resignation, with a total of 11 positions.

The Board inquired about the wayfinding signs. The City Liaison informed the Board that he would follow-up at the next meeting.

Having no more items to discuss, the Board confirmed the next meeting would be held on Thursday, August 11, 2022 at 6:30 PM.

Mr. Leiner motioned to adjourn. Seconded by Mr. Parker All were in favor. The meeting adjourned at 7:20 PM.
