Re: Political Signs Policy for Polling Places on Public or Private Property

The City of Sunrise currently has polling sites on City property, polling sites on Broward County property, and several polling sites on private property. To further the compelling governmental interest of allowing ample election-oriented speech in connection with an election polling place, a policy is needed to provide for the ability to have additional political signs at these polling locations during the time that they are used as polling places, over and above what the City's sign code would normally allow. A current list of polling sites is attached. The City shall refrain from enforcement of Section 16-254(f)(2) for political signs at polling sites and on the right-of-way immediately adjacent to those polling sites, provided the additional political signs conform to the following:

1. Candidates shall be entitled to install no more than one additional political sign at each polling site within the City.
2. If the polling site is not City-owned, the candidate must receive the permission of the property owner.
3. The additional political sign shall have a maximum area of six (6) square feet.
4. The additional political sign shall not be placed on the site being utilized as a polling site more than two (2) days prior to the date of the use of the site as a polling site.
5. The additional political sign shall be removed from the polling site no more than two (2) days after the polling site use has concluded.

All signs must comply with all applicable state and federal laws. As per Florida Statutes 102.031(4), political signs shall not be placed within one-hundred and fifty (150) feet from the polling site building entrance. In addition, political signs shall not be placed more than three hundred (300) feet from the polling site building entrance. At no point shall any political sign obstruct the sight visibility of any vehicle within any roadway, driveway, or right of way.

The City will remove and dispose of any political sign at any polling location that fails to comply with the above policy. Please note this policy replaces previous memos regarding political signs for polling locations.
