D. REVIEW AND APPROVAL OF MINUTES – July 14, 2022

Mr. Barnett motioned to approve the minutes. Seconded by Mr. Leiner. There was no further discussion. All were in favor.

E. OPEN DISCUSSION

The Public Observer inquired if the City would be applying for the next CSLIP Cycle. The City Liaison informed the Public Observer that the application is handled by a different Department within the City but confirmed the City would be applying. The Public Observer then inquired into specific details related to the City's application. The City Liaison responded that an update would be provided at the September Board meeting. The Public Observer described the Metropolitan Transportation Engineering & Construction Cooperative (MTECC) and encouraged the City to evaluate collaboration with the MTECC. The Public Observer also inquired about the City's participation in the Local Agency Program (LAP) managed by the MPO on behalf of the Federal Highway Administration (FHWA), to which the City Liaison responded that an update will be provided at the September meeting.

The Public Observer expressed concerns related to the operation of traffic signals as it relates to bicyclist specifically. The Board responded to the Public Observer's comments related to safety and signal operation, acknowledging that they themselves share the same concerns and have expressed those to the City in the past. The Board did note that they have seen many improvements in the City to address their various concerns throughout the years. The Public Observer noted that garbage bins and landscape maintenance trucks block the access to bike lanes. The Public Observer requested the City evaluate how this can be prevented.

F. OLD BUSINESS

The Board inquired if they can change the layout of the proposed way finding signs. The City Liaison informed the Board that it is an option and they can provide additional samples to be evaluated at future meetings.

The Board discussed the Bike Bingo template. The City Liaison advised to Board to mark their changes on the template and they would be discussed at the next BPAB meeting.

The City Liaison notified the Board that there was no update related to the dog waste receptacles throughout the City and that an update will be provided once available.

The City Liaison informed the Board that there is an indoor pickleball court at Sunrise Athletic Complex (SAC) Park, in the new Multipurpose Building. The City Liaison also noted that the City is investigating further ways to incorporate pickleball courts into the City's facilities.

The Board inquired if they could attend more events, as they observed opportunities to promote the Board at the grad re-opening of Welleby Park. The City Liaison noted an update would be provided once more information is available. The Board discussed making a list of all the events being held in the City to see if they can attend as the Board. The City Liaison would follow up with Leisure Services and get back to the Board.

G. NEW BUSINESS

There was no new business to discuss.

H. Board Forum

Having no more items to discuss, the Board confirmed the next meeting would be held on Thursday, September 8, 2022 at 6:30 PM.

I. ADJOURNMENT
