The City of Sunrise is committed to successfully recruiting and onboarding talented and skilled Veterans into the City's workforce. The City recognizes the extensive training, experience, and transferrable skills gained through military service.

The City of Sunrise Veterans Recruitment Plan is to encourage individuals eligible for veterans' preference in accordance with section 295.07, Florida Statutes, to seek employment opportunities with the City. This plan is designed to increase awareness among Veterans of employment opportunities with the City.

## Outreach Efforts to Military Veterans:

Human Resources team participates in numerous Job Fairs geared for Veterans and Military families. The largest job fair is Paychecks for Patriots, which attracts thousands of job seeking Veterans. Social Media posts notify Veterans of upcoming events.

Collaborate with local organizations including Career Source Broward and United Way Mission United to share job opportunities with job-seeking Veterans. Housing support, Employment services, Education, Legal assistance, Health and financial stability.

Assist Veterans with tips on translating Military Resume to Civilian Role. One on One coaching, resume assistance, and tips on reading job descriptions to identify transferable skills.
