Building Safety Inspection ProgramFrequently Asked Questions

What is the Building Safety Inspection Program?

The Broward County Building Safety Inspection Program was created in 2005 and has become effective throughout Broward County in January 2006. Modeled after Miami-Dade County's program, which was established in the mid 1970's, Broward's program calls for structural and electrical safety inspections for buildings 25 years and old or older and every ten years thereafter. One- and two-family dwellings, U.S. Government, State of Florida buildings, schools under the jurisdiction of the Broward County School Board, all buildings under 3,500 square feet, and buildings built on Indian Reservations are exempt from this program. By having such a program in effect both Broward and Miami-Dade counties are minimizing the possibilities of future building failure and will be better prepared for hurricane winds.

Why is my building due for a Building Safety Inspection?

A list of buildings due for a Building Safety Inspection are sent to each city throughout Broward County each year by the Broward County Board of Rules and Appeals. The list is based off of the actual construction year of the building according to the Broward County Property Appraiser records. If you feel there has been an error and your building should not be due for a Building Safety Inspection, please call (954) 572-2363.

PLEASE NOTE: Building Safety Inspections must be performed in the year they are due. The City will only accept Building Safety Inspection Reports for buildings that have been notified that a report is due.

Who performs the Building Safety Inspection?

A Florida State licensed architect or engineer must be hired by private building owners or property management to do the building safety inspection. The inspection reports must be filled out on the current Building Safety Inspection Report forms. The current forms can be downloaded at:

If my Building Safety Inspection Report(s) indicates "Repairs are Required", what are my next steps?

If either or both the structural or electrical report(s) are marked indicating "Repairs Required", the plan reviewer(s) will determine if permits are required based on the required repairs outlined in the report. Once all required permits have been obtained and all repairs have been made, your architect or engineer will need to submit a new Building Safety Inspection Report(s) to the City indicating "No Repairs Required". Once the City reviews and accepts the new report(s), your building will be in compliance with the Building Safety Inspection Program.

Building Safety Inspection Program Submittal Checklist

The Building Safety Inspection Reports must be submitted to the Building Division. The reports can be submitted in person or electronically via our Customer Self-Service Portal. Instructions are below for each method of submission.

Please carefully read through the requirements below for formatting requirements. Each item in the checklist below must be a separate file and in PDF (unprotected) format.				
	Building Safety Inspection Program Application . Please make sure the application is completely filled out, including the tracking number from the Building Safety Inspection notification previously received. Each building requires its own application and separate submission. A fee of \$431.50 per building is due prior to the processing of the submission.				
	Structural Safety Inspection Form (must be current version) . The report must be digitally signed and sealed by an architect or engineer. If the report cannot be digitally verified by our Plans Examiners, the report will not be accepted. Please make sure the report is completely filled out including <i>checking</i> either "No Repairs Required" or "Repairs are Required" on the cover page.				
	Electrical Safety Inspection Form (must be current version) . The report must be digitally signed and sealed by an architect or engineer. If the report cannot be digitally verified by our Plans Examiners, the report will not be accepted. Please make sure the report is completely filled out including <i>checking</i> either "No Repairs Required" or "Repairs are Required" on the cover page.
