Pine Plaza update – The residential portion is ready. The City is currently holding off on providing the certificate of completion until the developer fulfills their commitment for nearby task.

Golf Course (Housing Development) – The process is still ongoing for the land use approval.

Hospital update – The process is still ongoing. We are working on the property access issue with Baptist Health, the State and the County.
