On 08/26/2022 at 1847 hours I responded to a call put out by BSO dispatch as Lewd and Lascivious acts at the location of 12801 W Sunrise Blvd- Primark. Given the victim's age the call was later reclassified as a battery. I arrived to the scene after an arrest was made of the suspect in question.

Upon arrival I spoke with OFC D. Schwab who advised the following: (S1) Devon Samaroo entered the Primark store located at 12801 W Sunrise Blvd. While walking in the store Devon approached (V1) who was shopping in the lingerie section of the store. Devon walked in close proximity to and proceeded to intentionally touch as right butt cheek with his left hand. Devon with an open hand slid his hand across her buttocks, caressing her right buttocks cheek as he walked past her. Became startled when this occurred and immediately looked up at the defendant. Devon at that point threw his hands up and walked around once more before walking out of the store. Was then approached by two other individuals who stated that they saw Devon taking pictures of them. When the began to take a video of Devon as he walked out of the store. Haggard responded to Primark Management who in turn notified Mall Security and the Sunrise Police. Det. Haggard responded to Primark and spoke with He was given a description of Devon and issued a BOLO (Black male wearing Khaki pants, Black shirt, Black hat with the letter P, Blue mask and glasses).
who was working an off-duty detail at the Sawgrass Mills Mall was able to locate Devon, who exactly matched the BOLO given who was in full Class B uniform with Sunrise Insignia, then made contact with Devon. Informed Devon that he was not free to leave and that an investigation was being conducted. When he asked the defendant to identify himself, Devon refused to do so. Devon then turned and attempted to flee from was able to grab hold of Devon 's shirt. Devon began to struggle with at which time he was escorted to the ground so that better control could be achieved. Ultimately other officers responded and took Devon into custody.
After Devon had been taken into custody, a show up was conducted with positively identified Devon as the subject that had touched her.
I then spoke with Detective Haggard who advised the following: Det. Haggard advised he reviewed CCTV footage of the incident from Primark. In the footage Devon was observed passing by in close proximity. As Devon passed by is seen immediately looking at Devon. Devon was then observed walking around the victim once more prior to leaving the area.
provided a full taped statement to Det. Haggard in regards to the incident. stated that she did wish to pursue charges for the Battery.
I then spoke Devon. Devon was read Miranda warnings from a prepared text card. Post Miranda Devon advised the

Based on the statements made by Devon, he was placed under arrest for Battery and resisting an officer without violence.

While in custody, I began to notice Devon Moving awkwardly in the backseat of the patrol car. I asked Devon if he was alright, to which Devon advised he was having trouble breathing. Devon also advised when he is in stressful situations his epileptic seizures occur. Fire rescue was called to our location and Devon was transported by rescue 92, to Cleveland Clinic for medical issues. I rode with Devon in the fire rescue truck, while Ofc. Deweese followed. Devon was medically cleared by hospital staff, and he was ultimately transported to BSO main jail.

Under penalties of perjury, I declare that I have read the foregoing and that the facts stated therein are true and correct to the best of my knowledge and belief.
