<p>On 11/04/2022 at approximately 11:40 hours, while investigating a call at 3306 N University Drive, Sunrise, FL (Walmart East), I was alerted by the loss prevention officer of a theft in progress. The Lost Prevention officer was made aware of a black female, with a red hoodie, black leggings and a brown side purse running outside the east entrance with a stolen scooter. The LP asked Shacarldra to see the receipt, Shacarldra then said "fuck you" and proceeded to walk to her car.</p> <p>I made contact with Shacarldra before she could arrive to her car, where I requested her to show me the receipt for the scooter. Shacarldra said her sister had the receipt and kept walking away. I then told Shacarldra to stop until I saw proof of purchase. Shacarldra refused and attempted to walk away from me. I told Shacarldra that she was under arrest and to place her hands behind her back. She refused to comply and wedged one hand in between her body and another parked vehicle. I was only able to restrain one hand while she kept the other hand wedged. She continued to resist my commands and tensed her body. Eventually I was able to gain control of her arm where I conducted a leg sweep and guided her to the ground. I was able to gain compliance and placed her into restraints. Shacarldra sustained an abrasion to the right side of her shoulder area.</p>

On 11/04/2022 at approximately 11:50 am, I was conducting an investigation at 3306 N University Drive, Sunrise, FL (Walmart East).

I was alerted by Loss Prevention Officer (RP) Tijo Matthew that a female later identified as (OF) Shacarldra Bailey Robinson was exiting the store with unpaid merchandise. According to Loss Prevention, Shacarldra was pushing a shopping cart containing three unpaid scooters. Shacarldra went toward the Garden Section exit and was approached by a customer host who asked to see a receipt for the three scooters. Shacarldra ignored the host, picked up a scooter from the cart and ran out of the exit. Tijo observed Shacarldra fleeing out of the exit and into the parking lot, carrying the unpaid property. Tijo attempted to apprehend Shacarldra but she was uncooperative.

I followed Loss Prevention Officer Tijo when he advised me of the theft. I followed behind and observed Shacarldra walking out of the garden section, carrying a scooter. As I approached, Shacarldra stated that the scooter was paid for and that her sister had a receipt. I told Shacarldra to wait here while we attempted to figure things out. Shacarldra became irate, nervous and frantic as I attempted to question her. Shacarldra became uncooperative and tried to walk toward a parked vehicle. At this moment I advised her that she is detained for further investigation and to place her hands behind her back. Shacarldra refused and began to flail her arms around. I was able to restrain one arm but she wedged her other arm in between her body and a car so that I would be unable to place her in restraints.

Shacarldra refused to obey my commands to release her other arm and to stop resisting arrest. Eventually I grabbed her left arm and conducted a leg sweep. I guided her to the ground and was able to place her arms in restraints. While guiding her to the ground she sustained an abrasion to her right shoulder. She was brought to the Loss Prevention office and repeatedly said that she was going ██████████. Sunrise Fire rescue 59 arrived on scene to medically tend to Shacarldra. Shacarldra refused rescue. During the investigation, Shacarldra repeatedly stated that she was going to ██████████.

Shacarldra was ██████████ transported by officers to HCA Florida Woodmont for ██████████ evaluation. A return to Law Enforcement form was left with Hospital staff.

Tijo watched the video surveillance of the theft and stated that while the defendant was pushing the cart, she passed all points of sale with three scooters totaling in the amount of \$271.93. She picked up one scooter and ran out of the store where she was apprehended.

Tijo signed an affidavit wishing to press charges.

Pictures of the property, video of the theft and Shacarldra's injuries were uploaded to Sunrise Evidence.com

The receipt and Loss Prevention apprehension form were submitted into Sunrise evidence.

On this date while on a call at the Walmart 3306 N Univeristy Dr for a shoplifting, another subject was observed shoplifting and exited out of the garden center. At this point Officer Maristany went to go handle that shoplifting event, while myself and Officer Sevedra were handling the other one. (Officer Garcia was also present with the suspects of the initial shoplifting)

Soon after Officer Maristany left, I heard a lot of indiscernible transmissions coming from Officer Maristany and it sound like a fight was occurring. I then left the previous suspects with Ofc. Garcia to go assist. I ran out of the southern exit/entrance soon observed Officer Maristany and a black female subject in the parking lot. The female subject was on the ground in a prone like position and Officer Maristany was struggling with her to place his handcuffs on her due to her pulling away, and tensing. I ran over to them, and assisted Officer Maristany with placing the handcuffs on her. We then got her to her feet, and walked her into the loss prevention office.

She sustained two small abrasions to her right shoulder, and a small abrasion to her knee. She also complained about jaw pain. Sunrise Fire Rescue 59 was then requested at which point they evaluated her at which point she refused to be transported. Soon after they left, the subject stated she wanted to [REDACTED]. This was relayed to Officer Maristany where he ultimeatly initiated a [REDACTED] on the subject. He then transported the subject to Woodmont Hospital with me following them in my marked unit.


When we arrived to Woodmont Hospital and brought her to triage, she was very uncooperative with staff and wouldnt answer questions or obey commands. She was then brought back to the [REDACTED] area and turned over to their custody without incident.
