#### Narrative

Officers were dispatched to 2650 NW 64th Avenue in reference to a domestic disturbance. The victim relayed via text to dispatch that her ex-boyfriend who she has a restraining order against was at her home and threatening her and her children. Upon arrival to the residence, the subject was observed leaving the parking lot area. Ofc. Parks attempted to make contact with the subject just east of the residence and the subject ran southbound into a residential complex.

The subject was able to evade officers and a perimeter was established. Upon canvassing the area, I located the subject at the canal bank just east of 5951 NW 25th Street. As I approached the subject, he began to walk away from me (northbound). Ofc. T. Parks intersected him and he just stood between myself and Ofc. Parks. Multiple commands were given for the subject to "get on the ground" but he ignored our commands. It should be noted that Ofc. Parks and I were in full police uniform with badge, gun and agency patch. As Ofc. Parks and I moved closer to the subject, he placed his right hand in his waistband. Due to the subject's actions, I deployed my department issued Taser 7 (SN: X400HMY2). Subject was subsequently placed in handcuffs and he received medical treatment from Rescue 39 and FMC staff (medically cleared for jail).

On 12/12/22, I was dispatched to the listed address in reference to a domestic dispute.

(VI) stated that Tristan Coakley (OF) was asked to leave the residence several times, which he refused. Once noticed Coakley was not going to leave, she called law enforcement. As officers arrived, they observed Coakley running eastbound from the apartment complex's parking lot toward NW 60th Av.

Officers were able to locate Coakley at the rear of the housing development located at the 2500 block of NW 60th av, and he was given lawful commands to stop. It should be noted that Officers were in Sunrise PD uniform with insignia clearly displayed. Coakley disobeyed the commands and fled from officers southbound on NW 60th between residences. Officers were able to locate Coakley to the rear of the apartments located at the 2400 block of NW 60th Av, along the canal bank. Coakley was given commands to get on the ground before reaching toward his waistband, resulting in Coakley being tasered. See Ofc Martin's supplement for further information.

A routine database check of Coakley revealed that he has two active injunctions non-expiring against him, which were served (07/08/22, 08/25/22), with the protected person being Let it be known is the of Coakley Coakley was arrested on 07/07/2022 for "VIOL INJUNCTION PROTECTION DOM" and again on 08/24/2022 for "VIOL INJUNCTION PROTECTION DOM" (see Sunrise PD cases: 42-2207-028647 and 42-2208-036916). The injunctions were confirmed as active by Sunrise Police Teletype.

Coakley was read his Miranda Rights, which he invoked. Coakley was transported to Florida Medical Center for medical attention. The taser prongs were removed by Florida Medical Center staff. Coakley is charged with aggravated stalking, resisting without violence, and violation of an active injunction. Coakley was subsequently transported to BSO Main Jail for further processing.
