### ORDINANCE NO. 909-X-14-A

AN ORDINANCE OF THE CITY OF SUNRISE, FLORIDA, PERTAINING TO THE METROPICA IMPROVEMENT DISTRICT ("DISTRICT"), AMENDING ORDINANCE NO. 909-X TO REVISE TERRITORIAL BOUNDARIES OF DISTRICT; AUTHORIZING THE DISTRICT TO UTILIZE THE PROVISIONS OF ORDINANCE NO. TO IMPOSE AND COLLECT SPECIAL 567 ASSESSMENTS WITHIN ITS TERRITORIAL PROVIDING FOR CONFLICT; BOUNDARIES; FOR PROVIDING SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, effective March 23, 2004, the City Commission adopted Ordinance No. 909-X, creating the Metropica Improvement District ("District") and establishing its territorial boundaries as set forth on Exhibit "A" which are generally described as consisting of approximately 28.1 acres on a portion of Parcel "A" and "D" and all of Parcel "E" of the Metropica Plat, as recorded in Plat Book 148, Page 34 of the Public Records of Broward County, Florida; and

WHEREAS, effective July 15, 2014, the City Commission adopted Ordinance No. 579 which rezoned the property generally described as consisting of all of Parcel "A" of the Metropica Plat from B-3 (General Business) to PDD (Planned Development District) in order to facilitate the orderly development of the property in accordance with Section 16-109 of the Code of the City of Sunrise; and

WHEREAS, the City has determined that it is in the best interests of the City and the Metropica Improvement District to expand the territorial boundaries of the District by including Parcel "B" and a portion of Parcel "C" of the Metropica Plat within the Metropica Improvement District to ensure the entire property within the Metropica Plat will be cohesively developed; and

WHEREAS, effective October 22, 2013, the City Commission adopted Ordinance No. 567 (the "Master Assessment Ordinance"), which authorized the imposition of special assessments for capital projects and service assessments for services, facilities, programs and local improvements within the City and established procedures for the imposition and collection of such special assessments; and

WHEREAS, the City has determined that it is in the best interests of the City and the Metropica Improvement District to authorize the District to impose and collect necessary special assessments within its territorial boundaries for certain infrastructure to be built therein utilizing the procedures set forth in the Master Assessment Ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF SUNRISE, FLORIDA:

C14324 ORDINANCE NO. 909-X-14-A Section 1. The foregoing Whereas clauses are hereby ratified and incorporated as the legislative intent of this Ordinance.

Section 2. The territorial limits of the District as set forth on Exhibit "A" of Ordinance No. 909-X are hereby amended to include the property set forth in the legal description attached hereto as Exhibit "A" which supersedes Exhibit "A" to Ordinance No. 909-X and which is incorporated herein by this reference.

Section 3.
Section 7(c) is hereby created to read:

(c) The District is hereby authorized to impose and collect special assessments within the territorial boundaries of the District as it deems necessary, as though it were the City, in accordance with the procedures established in the Master Assessment Ordinance, as said Ordinance may be amended. In furtherance of the foregoing, for purposes of any special assessments imposed and/or collected by the Metropica Improvement District pursuant to the Master Assessment Ordinance, any reference to the City in said Master Assessment Ordinance shall be

deemed to refer to the Metropica Improvement District as if the District were the City.

Section 4. Conflict. All ordinances and parts of ordinances, all City Code sections or parts of City Code sections, and all resolutions in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 5. Severability. Should any provision of this Ordinance be declared by a court of competent jurisdiction to be invalid, the same shall not affect the validity of the ordinance as a whole, or any part thereof, other than the part declared to be invalid.

Section 6. Effective Date. This Ordinance shall be effective immediately upon passage by the City Commission on second reading.


