I hereby release, hold harmless, indemnify, and forever discharge the City and its employees, officers, directors, and agents from and against any and all causes of action, claims, demands, suits, costs including but limited to attorneys' fees and costs, which I, my heirs, representatives, executors, administrators, or any other persons acting on my behalf or on behalf of my estate have or may hereafter have arising out of or in connection with the City's taking and use of the Photographs and the photographed activities in which my child is taking part, including but not limited to any claims for defamation, invasion of privacy, invasion of right of publicity, misappropriation of likeness, infliction of emotional distress, negligence, any right, title or interest in the Photographs, and any other physical or monetary injury whatsoever.
