Auto Theft, Resist Arrest, Violation of Pre-Trial Release 5900 NW 15th St.

On the above date and time I observed an occupied stolen vehicle leaving the driveway of 5900 NW 15th St. Sunrise Florida. The vehicle, a 2017 Silver Lexus RC3 (Fl Tag- was reported stolen from Plantation (PLPD Case 2302-00203) and was taken approximately 1 hour and 15 minutes prior to this incident.

I pulled behind the stolen vehicle utilizing my Sunrise Police K9 SUV and activated my flashing blue emergency lights to conduct a felony traffic stop. As I exited my vehicle the driver and passenger of the stolen Lexus began to exit. I gave loud, clear and concise orders for the suspects to lay down on the ground, and warned them multiple times that if they ran, I would deploy my K9 partner. During this incident I was wearing my Sunrise Police K9 uniform.

The driver of the stolen Lexus initially complied and laid down on the ground and appeared to surrender. The passenger ignored my commands and began to flee southbound on foot from the traffic stop. As I gave the passenger additional commands to stop, the driver of the stolen Lexus suddenly stood back up, and began to flee on foot north across NW 15th St. Despite my multiple K9 warnings to the driver, he continued to flee away from the traffic stop on foot.

Based on the active resistance demonstrated by the suspect by fleeing from the stolen vehicle on foot, I deployed my K9 partner Rendor utilizing a tracking harness. K9 Rendor pursued the fleeing felony suspect and I ordered K9 Rendor to apprehended the suspect. K9 Rendor made contact with the suspect's right calf area, safely and effectively apprehending the suspect and preventing any further attempts to resist arrest in the backyard of 5901 NW 15th St. The suspect was placed into handcuffs by Plantation Police road patrol who arrived as backup without further incident. The suspect was identified as Antwon Waters 09/25/1995.

Sunrise Fire Rescue responded to the scene and transported Antwon to Florida Medical Center for evaluation for punctures sustained to the right leg during the K9 apprehension. Antwon was medically cleared for jail soon after by Dr. Ruangsomboon.

While at Florida Medical Center, I advised Antwon of his Miranda rights which he stated he understood. Antwon stated

A records check revealed Antwon does not have a driver's license. It should be noted that Antwon was armed with a folding knife that was located in his pocket during the time of arrest.

The second suspect was located by Plantation Police K9 Ofc. Mund and was taken into custody nearby. The second suspect was identified as Kamal Cherisma (12/26/86) and was placed under arrest by Sunrise Police Ofc. V. Fortune. (SPD Case 42-2301-005896).

Both suspects in this case acted in concert during the use and benefit of a stolen vehicle that was taken just an hour prior. Both suspects resisted arrest, fled from law enforcement on foot, and ignored police officers orders while fleeing, indicating their knowledge of the vehicles stolen status.

Plantation Police responded to the scene and recovered the stolen vehicle. Plantation Police indicated that

approximately \$1500 cash was inside of the vehicle at the time of theft. Both suspects were found to have currency of a combined total of \$803 on their person. The currency, along with the knife recovered from Antwon's pocket, were entered into SPD Evidence for further investigation.

It should be noted that during this incident, Antwon was on pre-trial release for previous burglary charges, and was wanted for arrest by Lauderhill Police (Case 29-2301-05865) for Commercial Burglary.

The second suspect was located by Plantation Police K9 Ofc. Mund and was taken into custody nearby. The second suspect was identified as Kamal Cherisma (12/26/86) and was placed under arrest by Sunrise Police Ofc. V. Fortune. (SPD Case 42-2301-005896).



A records check revealed Antwon does not have a driver's license. It should be noted that Antwon was armed with a folding knife that was located in his pocket during the time of arrest.

The second suspect was located by Plantation Police K9 Ofc. Mund and was taken into custody nearby. The second suspect was identified as Kamal Cherisma (12/26/86) and was placed under arrest by Sunrise Police Ofc. V. Fortune.

Both suspects in this case acted in concert during the use and benefit of a stolen vehicle that was taken just an hour prior. Both suspects resisted arrest and fled from law enforcement on foot and ignored police officers orders while fleeing, indicating their knowledge of the vehicles stolen status.

Plantation Police responded to the scene and recovered the stolen vehicle. Plantation Police indicated that approximately \$1500 cash was inside of the vehicle at the time of theft. Both suspects were found to have currency of a combined total of \$803 on their person. The currency, along with the knife recovered from Antwon's pocket, were entered into SPD Evidence for further investigation.

Both suspects were placed under arrest and transported to BSO Main Jail for processing.
