IN THE NAME AND BY THE AUTHORITY OF THE STATE OF FLORIDA:

HAROLD F. PRYOR, State Attorney of the Seventeenth Judicial Circuit of Florida, as Prosecuting Attorney for the State of Florida in the County of Broward, by and through his undersigned Assistant State Attorney, charges that TRAVIS ALEXANDER KELLEY, on the 8th day of January, A.D. 2023, in the County and State aforesaid, did knowingly commit a battery upon Officer and a duly qualified law enforcement officer of the Sunrise Police Department, while the said law enforcement officer was engaged in the lawful performance of his duties, in that the said Travis Alexander Kelley did actually and intentionally touch or strike the said law enforcement officer against his will, and at the time of such touching or striking, the defendant knew that Officer was a law enforcement officer, contrary to F.S. 784.03(1), F.S. 784.07(1)(d) and F.S. 784.07(2)(b), (L4).

COUNT II

Prosecuting Attorney for the State of Florida in the County of Broward, by and through his undersigned Assistant State Attorney, charges that TRAVIS ALEXANDER KELLEY, on the 8th day of January, A.D. 2023, in the County and State aforesaid, did unlawfully obstruct or oppose Officer a duly qualified and legally authorized law enforcement officer of the Sunrise Police Department in the lawful execution of a legal duty then being performed by the said officer, to-wit: investigation of disturbance, in that the said Defendant did refuse to leave the area and/or did resist being placed into handcuffs without the said Defendant offering or doing violence to the person of the said officer, contrary to F.S. 843.02
