F. OLD BUSINESS

Bike Bingo

The City Liaison informed the Board there have been no completed Bike Bingo cards submitted to date. The City's Marketing Team is going to re-promote the Bike Bingo cards. The City Liaison also informed the Board the City is exploring different prize options for those who have completed the Bike Bingo card.

Way-Finding Signs

The City Liaison informed the Board the City Manager's Office is supportive of moving forward with the program. The City Liaison will be submitting samples to the City's Marketing Team. The Board discussed the different locations they would like to see the Way-Finding Signs. The City Liaison informed the Board the Way-Finding Signs will be incorporated within City Right-Of-Way at this time.

Atrium Way Bus Route Loop

The City Liaison is still looking if the City's Shuttle Service is offered at this location. The City Liaison informed the Board he will also inquire with Broward County of there are any services offered at this location. Once further information becomes available the City Liaison will update the Board.

'Share the Road' Signs

The City Liaison informed the Board the 'Share the Road' Signs were not installed by the City; however, they were installed as a part of the Bike Lane Improvements Project along the Oakland Park Blvd Corridor for Broward County.

G. NEW BUSINESS

The Board inquired about trees being removed along NW 94th Avenue. The City Liaison will look into it update the Board once further becomes available. The Board inquired if the Art Wrap designs could be installed on all Utility Boxes throughout the City. The City Liaison informed the Board there is a program in the works and the City is coordinating with the Utility Franchise companies to have Art Wraps installed at Utility Boxes. The Board inquired if there is an updated design for the air release valves along NW 94th Avenue. The City Liaison will update the Board when further information becomes available.

The City Liaison informed the Board the new City Hall is now open to the public. The Board inquired when the old City Hall will be demolished. The City Liaison informed the Board there are still a few things that need to be accomplished before the demolition can occur. The City Liaison informed the Board the Board Meeting Locations will now be held in the new City Hall Location, within the Commission Meeting Overflow Room.

H. BOARD FORUM

The Board Chair informed the Board during the last Broward MPO meeting they discussed the Pat Salerno Interchange on the Sawgrass Expressway will be re-constructed to be able to go North and South. The Board inquired if there is any update regarding the City's Bicycle & Pedestrian, Greenways & Trails Master Plan. The City Liaison informed the Board the Consultants are working on this and will update the Board when more information becomes available. The Board Chair inquired if there is anything within the City's Code that enforces Bike Racks to be installed. The City Liaison informed the Board there are certain provisions within the City's Code that require Bike Racks, however, he will need to look into the specifics. The Board expressed their opinions on the Community Enhancement and Code Compliance Division expectations. The City Liaison will take the Boards concerns to the Division Head as well as the Department Director.

Having no more items to discuss, the Board confirmed the next meeting would be held on Thursday, August 10, 2023 at 6:30 PM.
