On June 18, 2023, at approximately 0204 hours, I heard a loud commotion in the parking lot of American Oak Plaza, located at 3800 N University Drive. I was with Officer Ray Rodriguez, who was working an off-duty detail at 3802 N University Dr. We proceeded to approach, and we observed a large crowd of people were kicking and punching a black male later identified as Kevin Noel. As we intervened, Noel stood up and struck me on the face with a closed fist. At this time, I responded with force, in response to Noel's aggressive resistance. I used the required force to compel compliance from Noel. I struck Noel on the face with two closed fists, as he continued to resist, I then struck him three times in the face with knee strikes. Once Noel complied, he was placed in hand restraints. A response to resistance report was generated and was submitted.

As Officer Ray Rodriguez was conducting a pat down on Noel, a black male wearing a white shirt later identified as Riginald Joseph, and a black male wearing a black shirt later identified as Rodger Dexter, started to approach Officer Ray Rodriguez in an aggressive manner. They were followed by a large group. They were both yelling and appeared to want to continue to fight with Noel. Dexter and Joseph were given multiple lawful commands to stay back, to no avail. Both subjects continued to antagonize and incite a crowd of people. Fearing for Noel's and Officer Ray Rodriguez's safety, I approached Joseph and stopped him from advancing any further. As I was engaged with Joseph, I felt people shoving me and grabbing me. At this time, I let go of Joseph. While doing so, I delivered two closed fist punches to one of the males of the group, who was grabbing my left shoulder. As that male fell to the ground, I turned to grab Joseph. While doing so, Dexter shoved me. I was able to grab both Joseph, and Dexter, and re-direct them to the ground. While on the ground they both continued to resist my efforts to detain them. A short while later, more officers arrived on scene and assisted in placing Joseph and Dexter in hand restraints.

Let it be known, Joseph and Dexter were accompanied by approximately twenty people. The scene was chaotic and it took multiple officers to arrive and gain control of the scene. Joseph and Dexter were later transported to BSO Main Jail. As for Noel, he was transported to Woodmont Hospital in reference to a laceration. My body worn camera was activated. As for the male I struck with two closed fist punches, I was not able to locate and identify him from the large group. Due to the large commotion and confusion, I did not get a good look at him as I was being attacked.

Contact was made with staff, who are employed with La Perrada Restaurant, located at 3800 N University Drive. CCTV video was later obtained and submitted into evidence.com.

On 6/18/2023, I responded to 3801 N University Dr in reference to a disturbance.

Upon my arrival, I made contact with Officer Raymond Rodriguez (SN3760) who had three black males detained. Ofc. Rodriguez advised that there was a physical altercation between customers at Velvet Lounge(See Ofc. Rodriguez's and Sgt. [REDACTED]s supplement for further).

It is to be noted that prior to my arrival, one of the males obtained an eye injury and was transported to HCA Woodmont Hospital for medical clearance. I later identified the male as Kevin Noel via FLDL. A records check for Kevin yielded negative for any wants or warrants.

Once I arrived on the scene, I took custody of Riginald Joseph and transported him to the Sunrise Police depart for paperwork. I conducted a records check for Riginald which yielded negative for any wants or warrants. I then conducted a records check for Roger Dexter which yielded positive for Dexter being on probation for Burglary of an occupied structure out of Palm Beach County.

Riginald was charged with trespassing after warning and resisting without violence. Kevin was charged with trespassing after warning and resisting without violence along with battery on a law enforcement officer. Roger was charged with trespassing after warning and resisting without violence along with battery on a law enforcement officer and violation of probation.

Once I completed the necessary paperwork, Ofc. Richardson took custody of both Roger and Riginald and transported them to BSO main jail without further incident.





On 06/18/23, I was on an off-duty detail at 3802 N University Dr. SGT [REDACTED] and I were standing outside of the business when I heard a loud commotion by the front door, and staff were yelling for help. We proceeded to approach, and a large crowd of multiple people were kicking and punching a black male later identified as Kevin Noel. I observed Kevin getting up and striking SGT [REDACTED] on the side of the head while I was clearing others out of the area.

I proceeded to help SGT [REDACTED] apprehend Kevin and place him in handcuffs. While I was securing the handcuffs and conducting a pat down, I observed a black male wearing a white shirt later identified as Riginals Josph, and a black male wearing a black shirt later identified as Rodger Dexter, approaching my position with an aggressive demeanor. They were both yelling and appeared to want to continue to fight with Kevin. Officers gave multiple lawful commands to stay back to which they both did not comply. Both subjects continued to antagonize and incite a crowd of people. SGT [REDACTED] approached Riginals and stopped him from advancing any further for my safety and that of Kevin. While SGT [REDACTED] was engaged with Riginals, Rodger shoved SGT [REDACTED]

SGT [REDACTED] grabbed Riginals and Rodger. I observed SGT [REDACTED] attempting to subdue both males, which caused me to leave Kevin and assist SGT [REDACTED]. Both subjects continued to resist myself and SGT [REDACTED]'s efforts to detain them. A short while later, more officers arrived on scene and assisted with gaining control of the scene.
