The City Liaison provided the Board an update regarding Bike Bingo. The City's Marketing Team is going to re-advertise the Bike Bingo. The City Liaison informed the Board that Way-Finding Sign samples are being prepared to be presented before the Board for their feedback. The City Liaison is still looking into the Atrium Way Bus Route Loop and will provide further information once it becomes available.

G. NEW BUSINESS

Broward County Mobility Master Plan

The City Liaison informed the Board the County is looking for participants for a focus group to provide feedback for biking throughout the County. The contact information for registering as a participant was provided.

H. BOARD FORUM

The Board inquired if the City has any plans to plant canopy trees along sidewalks and bike lanes. The City Liaison informed the Board that there is no specific project associated with the installation of canopy trees abutting sidewalk or bike lanes, but that the City's Public Works group has a yearly program to install Trees within ROW and City facilities. The City Liaison also noted that during the review of development applications, shading via canopy trees is encouraged. The City Liaison informed the Board of the different programs the City offers for tree planting and funding. The City Liaison informed the Board there is no update with the Mobility Plan and will provide further information once it becomes available. The Board inquired if they will have an opportunity to review the Master Plan before it goes before Commission. The Board also inquired if there are any workshops or presentations regarding the Master Plan they would like to be invited to have the opportunity to see the plans. The City Liaison will look into this and provide an update at the next Board meeting. The Board inquired if additional parking signs can be installed at SAC Park. The City Liaison will look into this and provide further information when it becomes available. The Board chair encouraged the Board Members to notify the City of any issues they observe to provide the City and opportunity to resolve.

Having no more items to discuss, the Board confirmed the next meeting would be held on Thursday, September 14, 2023 at 6:30 PM.
