## 30 Day Temporary Power Connection Affidavit

The issuance of a 30-day temporary power connection permit is governed by Section 112 of the Broward County Amendments to the Florida Building Code 5th Edition. The usage of power is only for the purpose of testing building service systems or for use under a Temporary Certificate of Occupancy.

This permit is for a period of thirty (30) days and must be renewed if a Certificate of Occupancy is not issued in this time period. Temporary power will only be granted for two 30-day periods unless there are special conditions. These special conditions must be outlined in a letter to the Building Official or Chief Electrical Inspector and indicate the projected date of the Certificate of Occupancy. This letter must be submitted with Broward County Uniform Building Permit Application and City of Sunrise Electrical Addendum.

This affidavit does not release the structure listed below for purposes of use and occupancy. It is the responsibility of the contractor to maintain the safety of the electrical system and to provide job procedures that will prevent any unsafe use of the power. The Building Official or Chief Electrical Inspector shall have the authority to authorize disconnection of utility service to the building, structure, or system regulated by the reference codes and standards set forth in Section 101.4.1 through 11 in case of emergency where necessary to eliminate an immediate hazard to life or property or when such utility connections have been made without the approval required by Section 112.1, 112.2, or 112.3.
