The applicant's team and DRC staff members (see below contact information list) discussed comments for the proposed Revised Site Plan and Special Exception applications for Enterprise Rent a Car.

Planning comments, prepared by Ana Parada, Assistant City Planner. Per the applicant's solicitation, Jim Koeth, Assistant Director/City Planner, and Ms. Parada commented on the following DRC planning comments:

Revised Site Plan – Planning comments:

On page 1, comment (B)(1), a specific property survey has been included for both applications with the original raised seal and a wet signature. Ravindra Ramgulam, City Engineer, will review the survey and provide comments (if any) in the next resubmittal.

On page 2, comment (C)(4)(b), the applicant stated that the table of contents has been revised to include sheet numbers and descriptions as requested. Ms. Parada confirmed that the drawings presented at the meeting reflected the changes.

On page 3, comment (E)(1)(b), Mr. O'Gorman requested a condition of approval for the Site Plan application to provide the required statement signed by the engineer of records or contractor certifying that the existing rims are traffic rated, at the time of building permit. Mr. Ramgulam confirmed that the statement could be provided as part of the building permit application.

On page 4, comment (E)(6)(b), Mr. O'Gorman showed that a cross-section on Sheet A-2 was included, showing the location of the proposed mechanical equipment and the existing parapet that will screen the new unit on the rooftop. Ms. Parada confirmed that the drawings presented at the meeting included the cross-section.

The City Engineer, Ravi Ramgulam, confirmed that it is acceptable to provide at both sides of the bay door landscape islands with low/medium landscape material, satisfying the engineering comment (B)(4)(a). Mr. Ramgulam agreed to evaluate the landscape requirements at the time of the building permit.

#### Special Exception – Planning comments:

On page 2, comment (D)(2), the applicant stated that the parking data table for the Special Exception application had been updated to match the information provided for the Site Plan application, removing discrepancies.

Jim Koeth, Assistant Director/City Planner, suggested providing a narrative of the public notices delivered to the adjacent residential property owners, attaching a copy of the written information provided, and describing the response received. Before concluding the meeting, the applicant agreed to provide the information with the next DRC submittal.
