



Business Impact Estimate Form

This Business Impact Estimate Form is provided in accordance with Section 166.041(4), Florida Statutes and must be included in the agenda item backup for each proposed ordinance on first reading. A Business Impact Estimate Form must be prepared and posted on the City's website for each ordinance by the date that the notice of the proposed ordinance is published, regardless of whether the ordinance is exempted under Section A. below. This Business Impact Estimate Form may be revised following its initial posting.

Title and C# of proposed ordinance:

C23391, First Reading of an Ordinance of the City of Sunrise, Florida, calling for a Municipal Election to be held on Tuesday, November 5, 2024 for City Commission Seats "A" and "B" and the "Mayor" authorizing the City Clerk to proceed with all aspects of the election; providing for conflict; providing for severability; and providing an effective date. City Manager Mark Lubelski. Felicia M. Bravo, City Clerk.

The provisions contained in this Section A. constitute exemptions as provided in Section 166.041(4)(c). If one or more boxes are checked in Section A. below, a business impact estimate is not required by state law for the proposed ordinance.

Section A.

- The proposed ordinance is required for compliance with Federal or State law or regulation;
- The proposed ordinance relates to the issuance or refinancing of debt;
- The proposed ordinance relates to the adoption of budgets or budget amendments, including revenue sources necessary to fund the budget;

The purpose of the ordinance is to authorize the City Clerk to proceed with all aspects of the municipal election process, including the required advertising, selection of polling places, pollworkers, ballot preparation and printing, equipment use and certification costs in furtherance of representative democracy in the City of Sunrise. The ordinance is required to be adopted pursuant to City Charter Sec. 6.02 and 6.04.
