Stunning Sunrise Award - Roberta inquired about the Stunning Sunrise Award. Danielle explained that the program should be running quarterly. The Community Development Department may not be receiving a ton of applications to continue the program quarterly. Vivian asked how the program is marketed. Danielle explained that the program is marketed through city social media platforms and the City of Sunrise website. Code enforcement officers also assist by placing door hangers on residential properties that are well taken care of and encourage homeowners to apply. The program incentives homeowners to invest in the facade of their homes. Annie suggested advertising the program in Horizon Magazine. Danielle will inquire about a status update and provide it at the next meeting.

Shop Sunrise - Danielle asked the Board why they don't take advantage of the Shop Sunrise program. Annie shared that most staple restaurants are not part of the program. Danielle encouraged the Board to assist with the program by informing businesses that are not yet affiliated with the program, to sign up. Maria suggested adding additional incentives to encourage businesses to complete the gift card registration for the program.

Annie asked when the city will determine when the program is no longer worth pursuing. Danielle explained that currently there is no end date for the program.
