New Business

Youth Athletic Programs Update- Richard Devaux, Division Director, and Michael Cuminale, Recreation Specialist in Athletics, gave an update of the City's in-house programs that include Baseball & Softball, Basketball, Flag Football & Cheerleading and Soccer. The Baseball and Softball programs are currently underway with approximately 300 participants. We are partnering with the City of Plantation for Softball. We also sponsor a baseball team that participates in the Challenger Baseball League. Athletic staff is working with 82 volunteer baseball and softball coaches, offering training videos with skills drills and helpful hints for speaking to parents and game officials to help each coach have a successful season. Staff continues to work with the coaches in expanding their Athlete of the Month nominations, which will help this board with selection.

The City offers a 50% registration for one child of each volunteer coach, and with funding through the American Rescue Plan Act (ARPA), eligible participants can receive a \$50.00 Dick's Sporting Goods gift card.
