Emilie explained that for years, the city advocated for state and federal funding for facilities, wellness activities, and resources for Veterans, but has yet to be successful. The City's state and federal Lobbyists assist with these requests by advocating on behalf of the city. The Board requested to invite Congresswoman Sheila Cherfilus-McCormick to discuss funding for Veterans.

## a. City Advisory Board Liaison Information and Dates

Each Board member was invited to selected an advisory board to liaison throughout the year. Member Young asked if Board members are required to attend all meetings throughout the year. Emilie explained that Board members are not expected to attend every meeting but ideally 1 or 2 meetings yearly.
