D. OPEN DISCUSSION

E. REVIEW APPROVAL OF MINUTES - MAY 9, 2024

Mr. Leiner Motioned to approve the minutes. Seconded by Mr. Fernandez. There was no further discussion. All were in favor.

F. OLD BUSINESS

1. Sunrise Bicycle & Pedestrian, Greenways & Trails Master Plan Update

City Liaison informed the Board that he has requested the schematics for the routes and linear feet for new bike lanes and will provide the samples to the Board before the official Master Plan update. The Way-Finding signs design concept has been updated with incorporated feedback from the Board and the consultant. City Liaison will present examples from the new design iteration when it becomes available.

2. Atrium Way Potholes

City Liaison notified the Code Compliance group about the potholes that were present along Atrium Way and intends follow up on the status. A Board member confirmed that the potholes have indeed been fixed.

G. NEW BUSINESS

1. League of American Bicyclist Membership Renewal

City Liaison passed around a pamphlet received from the American Bicyclist Association and informed the Board of the City's upcoming membership expiration. The City Liaison is currently working on renewing the membership as well as reviewing the requirements for seeking higher certification status. Board member questioned if the League of American Bicyclist provides signs to represent to the community of the current Bronze status. City Liaison will inquire with the representative from the League of American Bicyclist and the City's Capital improvements group about the availability and potential for signage to showcase the City's various accolades.

H. BOARD FORUM

The Board expressed gratitude to City staff for working to minimize the impact of the flooding from the recent rain storms. Board member discussed the Disability Rights Education & Defense Fund Survey being conducted by Smart Growth America that will become a resource to better understand the needs for pedestrians as well as drivers with disabilities. The Board inquired about the construction along Oakland Park Blvd and Nob Hill Road. City Liaison informed the Board the active project along that intersection is in collaboration with Broward County and is intended to provide improvements such as pedestrian crossing, sidewalks and drainage. The City Liaison also provided details on upcoming construction that will significantly impact the roadways including maintenance of traffic set ups. Having no more items to discuss, the Board confirmed the next meeting would be held on Thursday, July 11, 2024 at 6:30 PM.
