D. **OPEN DISCUSSION**

E. **REVIEW APPROVAL OF MINUTES – JUNE 13, 2024**

## **F. OLD BUSINESS**

### **1. Sunrise Bicycle & Pedestrian, Greenways & Trails Master Plan Update**

City Liaison did not have an update at this time and will provide one in next upcoming meeting.

### **2. Atrium Way Potholes**

City Liaison informed the Board that the City's Public Works division verified that the potholes have indeed been rectified. City Liaison provided a message from Assistant Deputy Director of Utilities expressing gratitude for the feedback.

### **3. League of American Bicyclist Membership Renewal (Bicycle Friendly Community)**

City Liaison informed the Board that the City's application to the League of American Bicyclists Bicycle Friendly Community (BFC) program was successfully submitted. City Liaison distributed informative materials regarding the Bicycle Friendly Community application to the Board. The City Liaison noted that the City's committee decided to pursue the bronze status recertification based on the grading criteria for the program. The City Liaison informed the Board that a new updated bike network map has been added to the City's website. A survey will become available from the League of American Bicyclist Association to receive feedback from the Board and the community. City Liaison mentioned an action plan being put in place to create activities that may lead to an opportunity for silver status in the future. The Board questioned different opportunities that the Board can implement to further lead to the status improvement. City Liaison will seek guidance and information regarding the items discussed and will provide feedback to the Board.

## **G. NEW BUSINESS**

### **1. CSLIP Grant Application**

An Engineer from the City's Public Works division presented information on the City's application to this cycle's Complete Streets & Localized Initiatives Program (CSLIP) through the County's Metropolitan Planning Organization (MPO). The City's roadway sections for this cycle's application are the NW 94<sup>th</sup> Ave/ NE 42<sup>nd</sup> Ave/NW 50<sup>th</sup> St, and Springtree Drive and NW 84<sup>th</sup> Ave corridors, which would both undergo modifications for improved bicycle lanes. The Board inquired if these new proposed bicycle lanes are interconnected with those of previous applications which would lead to a connected system throughout the City. Ms. Molina-Kelly Motioned to support the grant submittal. Seconded by Mr. Barnett. All were in favor.

## **H. BOARD FORUM**

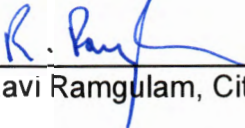
