If approved, I agree to pay the total sum of the following items: the reduced value of the eligible lien(s) on the Property, the unreduced face value of any lien under \$1,000, the full amount due for any lien that was reduced by Order of the Special Magistrate, and the cost per lien of lien preparation and recording. I will make such payment to the order of the City of Sunrise and understand and agree that payment in full by cashier's check must be received by the Community Enhancement & Code Compliance Division on or before December 31, 2026. Should I fail to make payment in full by December 31, 2026, I understand and agree that the approved lien reduction(s) shall be null and void and that I will be liable for the entire face value of the lien(s) as if no reduction had ever been imposed and the application fee(s) are nonrefundable.
