## **New Business**

Fire Rescue Programs- Guest speaker, Danielle DiGiacomo, Fire Prevention Specialist, gave an overview of the programs available through Sunrise Fire Rescue. Programs include educational fire prevention presentations at elementary schools and pre-schools, the Community Paramedic Resource Access Program (connects residents with appropriate medical, mental health, and social resources), and two volunteer programs - Fire Explorers for teens and Community Emergency Response Team (CERT) for adults.

Lorelei Boyden was interested in the Yellow Dot Program, in which one would place a yellow dot decal on the rear driver's window of their car to alert first responders that there is a medical information card in the glove box. Satnarine Ricketts-Weller was interested in setting up an informational meeting for the residents at the Sunrise Lakes Phase where she lives. Todd Shipley asked about the Child Safety Seat Program. He was informed that car seats are not always available but to reach out the Fire Rescue office.

Youth Athlete of the Month- The board reviewed the nominations from the Youth Recreation Basketball Program. Discussion followed. The board recommended that Luke Bell and Olivia Simpson receive the Youth Athlete of the Month Awards. The nominees will be recognized at the September 10<sup>th</sup> City Commission Meeting.
