1. Sunrise Bicycle & Pedestrian, Greenways & Trails Master Plan Update

The City Liaison showcased the latest Master Plan update to the Board via a PowerPoint presentation. Board members provided feedback and suggestions that would best suit the needs of the community. Feedback included updates to the way-finding signs concept proposed and reevaluating the project prioritization. The Board further inquired on the classification and selection criteria for project prioritization selection. It was suggested by the Board that the project prioritization criteria be reevaluated to include projects that may be completed in a timelier manner. The City Liaison provided feedback on the standard process for these project types and highlighted challenges that may impact the prioritization. The Board also suggested a status tracking system specific for projects identified in the Master Plan to be available online.

2. League of American Bicyclist Membership Renewal (Bicycle Friendly Community)

The City Liaison distributed to the Board a copy of an email from the League of American Bicyclist which included a link for Sunrise residents/visitors to complete a survey to provide feedback on their experience as a bicyclist within the community and how bicycle friendly they consider the community. The City Liaison encouraged the Board to complete the survey and promote it through all platforms. The City Liaison provided feedback on the application process and also noted that a flyer will be created to further promote the survey on the City’s website as well as social media platforms.
