On 06/15/2024, at approximately 21:48 hours, Sunrise Police Officers were dispatched to the Target department store parking lot, located at the Sawgrass Mills Mall, 12801 West Sunrise Boulevard, in the City of Sunrise, County of Broward, State of Florida, in reference to a group of juveniles lighting off fireworks on mall property.

Upon arrival, I made contact with Sawgrass Mills Mall Security personnel, who identified the group of juveniles they observed lighting fireworks on mall property. At the request of mall security, I trespassed the group of five juveniles (one black female, four black males) from the entirety of mall property, and instructed them to immediately vacate the premises.

Rather than immediately vacating the premises, the juveniles paused multiple times to light off more fireworks. I then provided the juveniles' location over the radio, for additional responding officers to again make contact with the advised over the radio that the juveniles were still group. Shortly thereafter, Sunrise Police Sergeant lighting fireworks on property, and running away from him. With the overhead emergency lights and siren of my marked City of Sunrise police vehicle activated, I attempted to (OF), as he was fleeing on foot on Azure Alley toward NW 136th stop one of the juveniles, Avenue (still on mall property). I then pulled ahead of exited my vehicle, and in full road patrol uniform with badge and insignia affixed, ordered to get on the ground. It is disregarded my commands, and continued toward NW 136th Avenue on Azure Alley. he continued to refuse lawful commands to get on the ground, and braced and Upon making contact with tensed his body in an attempt to resist my efforts to detain him.
